#### **Applications from non-governmental organizations for consultative status**

Note by the Director-General

Provides information on the following non-governmental organizations applying for consultative status with UNIDO: Oasis Open City Foundation (FOCA), International Centre for Trade and Sustainable Development (ICTSD) and International Investment Center (IIC).

1. In accordance with Article 19.1 (b) of the Constitution of UNIDO and the Guidelines for the Relationship of UNIDO with intergovernmental, governmental, non-governmental and other organizations (decision GC.1/Dec.41), in particular paragraph 17 of the annex thereto, information on three non-governmental organizations (NGOs) seeking consultative status with UNIDO is circulated to the members of the Board in the annex to the present document. More detailed information on the NGOs is available with the Secretariat.

2. Paragraph 17 of the annex to the Guidelines stipulates that the Board shall establish appropriate procedures for reviewing applications from NGOs for consultative status. To facilitate and accelerate its work, the Board may wish to follow the practice established at previous sessions and request the Bureau of the Board to review the application of, and information on, the three NGOs referred to in the annex to the present document and to submit its recommendations to the Board for consideration at its current session.

##### Historical background

FOCA was founded in 1989 in order to promote the concept of the open city as a place of reconciliation of the cultural values of civil society, such as environment, social cohesion, economic growth and access to services for everybody. FOCA develops programmes, projects and activities so as to improve the quality of life and facilitate the harmonic integration of human beings with nature, economic growth and the environment.

##### Activities related to the work of UNIDO

FOCA focuses on sustainable territorial development and educational programmes carried out especially in rural municipalities and areas. Within that context, it implements projects and programmes in the following areas:

- Agriculture development: One of FOCA's most significant projects is Biopolis, a local develop-

ment initiative aiming at the revitalization of the state of Paraná. Biopolis is developing a sustainable agriculture and food-processing industry and converting local resources into saleable products and services, while creating a quality trademark of the area so as to promote products and services. Furthermore, an overall strategy, capable of integrating and interlinking sectors of activities and local players, has been designed;

- Territorial enhancement and development: Important initiatives are Guaraqueçaba laboratory park, Amazon programme, national consortium for recycling, Open City Certification (OCC) and the Brasilia Declaration on Rural Municipalities Sustainability;
- Environment and research: The project of ecological studies of long duration (PLOT) and carbon sequestration studies address ecosystems;
- Education: FOCA undertakes activities in the field of communities' empowerment and educational programmes for citizen and child development. It established the University for the Future providing a post-graduate programme for teachers and technical specialization courses;
- Health and safety: A health bank was established to provide poor communities with basic health services.
