### Introduction

1. The Programme and Budget Committee held its twentieth session at UNIDO Headquarters, Vienna International Centre, on 8 and 9 September 2004. All 27 Members of the Committee participated in the session: Austria, Cameroon, Côte d'Ivoire, Democratic People's Republic of Korea, Ethiopia, Finland, France, Germany, Greece, Guatemala, Hungary, India, Indonesia, Italy, Japan, Mexico, Morocco, Nigeria, Pakistan, Peru, Poland, Republic of Korea, Russian Federation, Sudan, Turkey, United Kingdom of Great Britain and Northern Ireland and Venezuela.

2. The following 65 Members of UNIDO also attended the session: Afghanistan, Albania, Algeria, Angola, Argentina, Azerbaijan, Belarus, Belgium, Bolivia, Bosnia and Herzegovina, Brazil, Bulgaria, Burkina Faso, Cape Verde, China, Colombia, Costa Rica, Croatia, Cuba, Cyprus, Czech Republic, Denmark, Ecuador, Egypt, Iran (Islamic Republic of), Iraq, Ireland, Israel, Jordan, Kenya, Lebanon, Libyan Arab Jamahiriya, Lithuania, Luxembourg, Malaysia, Malta, Monaco, Namibia, Netherlands, Norway, Oman, Paraguay, Philippines, Portugal, Romania, Rwanda, Saudi Arabia, Serbia and Montenegro, Slovakia, Slovenia, South Africa, Spain, Sri Lanka, Sweden, Switzerland, Syrian Arab Republic, Thailand, The former Yugoslav Republic of Macedonia, Tunisia, Ukraine, United Arab Emirates, Uruguay, Viet Nam, Yemen and Zimbabwe.

3. The following organizations were represented: European Commission, International Atomic Energy Agency, International Centre for Genetic Engineering and Biotechnology, International Institute of Refrigeration, League of Arab States and Organization of the Petroleum Exporting Countries.

4. In accordance with rule 17 of its rules of procedure, the Committee elected by acclamation Mr. I. Horváth (Hungary) as Chairman; Mr. E. Peña Haller (Mexico), Mr. G. Asiegbu (Nigeria) and Mr. Kim Chong-hoon (Republic of Korea) as Vice-Chairmen; and Mrs. J. Kayihan-Ercin (Turkey) as Rapporteur.

5. The agenda for the twentieth session as adopted by the Committee is contained in document PBC.20/1/Rev.1. Following the adoption of the agenda, the Director-General made an introductory statement that was duly taken into account by the Committee in the consideration of the relevant agenda items.

6. The report of the Programme and Budget Committee is submitted to the Industrial Development Board in accordance with Article 10.4 (d) of the Constitution.

7. The report contains the conclusions reached by the Committee. The annex to the present report contains a list of documents submitted to the Committee at its current session.

8. The following conclusions of the Committee contain recommendations that call for action by the Board at its twenty-ninth session or are of relevance to the work of that session:

### I. ORGANIZATIONAL MATTERS

9. On 8 September, the Committee considered a proposal by the Chairman to optimize the *utilization of available conference-servicing resources* and adopted the following conclusion:

#### **Conclusion 2004/1 UTILIZATION OF AVAILABLE CONFERENCE-SERVICING RESOURCES**

The Committee, with the aim of utilizing the available conference-servicing resources to the maximum extent possible, decided to suspend with immediate effect rule 24 of its rules of procedure relating to the quorum, for the meetings of its twentieth session only, provided no substantive decisions were taken at those meetings.

10. The Committee also decided to set up informal in-session consultations with the aim of facilitating the drafting of conclusions and entrusted Mr. G. Asiegbu (Nigeria) (Vice-Chairman) to chair those consultations.

## II. SECURITY ENHANCEMENTS AND PROPOSED NEW CONFERENCE FACILITIES (item 7)

11. On 8 September, the Committee considered a note by the Secretariat on security enhancements and proposed new conference facilities (PBC.20/7).

12. On 9 September, after consideration of a draft conclusion on *security enhancements*, submitted by the Chairman (PBC.20/L.2), the Committee adopted the following conclusion:

### Conclusion 2004/5 SECURITY ENHANCEMENTS

The Programme and Budget Committee:

(a) Took note of United Nations General Assembly resolution 58/295 on strengthening the security and safety of United Nations operations, staff and premises and of the financial requirements for the initial phase of security enhancements at the Vienna International Centre (VIC) amounting to \$8.4 million, with a UNIDO share of \$1.38 million;

(b) Noted the importance that all Member States enable UNIDO to finance its share of security enhancements;

(c) Also took note of the information provided in document IDB.29/7-PBC.20/7 concerning security enhancements in the VIC and of the views expressed during its current session on that issue;

(d) Decided to refer the matter concerning the financing of UNIDO's share to the Industrial Development Board at its twenty-ninth session and to that end requested the Secretariat to provide the Member States with detailed information on several funding options, taking into account the diverse views expressed during the current session.

## III. MEDIUM-TERM PROGRAMME FRAMEWORK, 2006-2009 (item 8); DRAFT COOPERATION AGREEMENT WITH THE UNITED NATIONS DEVELOPMENT PROGRAMME (item 9)

13. The Committee decided to discuss simultaneously items 8 and 9.

### A. Medium-term programme framework, 2006-2009 (item 8)

14. On 8 September, the Committee considered proposals by the Director-General on the medium-term programme framework, 2006-2009 (PBC.20/6).

15. On 9 September, at the suggestion of the Chairman, the Committee took note of the information provided by the Director-General on item 8.

### B. Draft cooperation Agreement with the United Nations Development Programme (item 9)

16. On 8 September, the Committee considered the recommendation of the informal advisory group on decentralization on the draft cooperation Agreement with the United Nations Development Programme (PBC.20/9).

17. On 9 September, after consideration of a draft conclusion on the *draft cooperation Agreement with the United Nations Development Programme*, submitted by the Chairman (PBC.20/L.7), the Committee adopted the following conclusion:

### Conclusion 2004/6 DRAFT COOPERATION AGREEMENT WITH THE UNITED NATIONS DEVELOPMENT PROGRAMME

The Programme and Budget Committee:

(a) Considered the importance of carrying forward the process of decentralization to the field and of further strengthening and rationalizing the field operations of the Organization as mandated by General Conference resolutions GC.10/Res.2 and GC.10/Res.10 and Industrial Development Board decision IDB.28/Dec.2;

(b) Noted with appreciation the work of the informal advisory group on decentralization, as outlined in documents IDB.28/6 and IDB.29/9-PBC.20/9, as well as the efforts of the Director-General in that respect;

(c) Acknowledged the benefits of the proposed Agreement with the United Nations Development Programme, as outlined by the Director-General in his opening statement to the current session, including:

- (i) UNIDO will receive financial support from UNDP during a pilot phase of two years;
- (ii) UNIDO will be able to significantly increase its field presence;
- (iii) UNIDO will develop an additional portfolio of technical cooperation projects, particularly to implement the recommendations of the Commission on the Private Sector and Development of the United Nations Secretary-General;

(d) Took note of the intention of the Director-General to conclude the Agreement with the United Nations Development Programme;

(e) Requested the Director-General to submit to the Industrial Development Board and the General Conference a progress report on the implementation of the Agreement for consideration;

(f) Requested the Director-General to submit to the next Industrial Development Board for its information an implementation plan of the strategic alliance with the United Nations Development Programme;

(g) Recommended that the implementation of the strategic alliance with the United Nations Development Programme does not negatively affect the existing projects and the field structure as a whole during the pilot phase;

(h) Recommended that at the end of the pilot phase an assessment of the results and the decision on the continuation of the strategic alliance with the United Nations Development Programme shall be made in close consultation with Member States in the thirty-second session of the Industrial Development Board.

#### **IV. FINANCIAL SITUATION OF UNIDO (item 5); MOBILIZATION OF FINANCIAL RESOURCES (item 6)**

18. The Committee decided to discuss simultaneously items 5 and 6.

##### **A. Financial situation of UNIDO (item 5)**

19. On 8 and 9 September, the Committee considered a report by the Director-General on the financial situation of UNIDO (PBC.20/8), updated in a note by the Secretariat (PBC.20/CRP.3).

20. On 9 September, after consideration of a draft conclusion on the *financial situation of UNIDO*, submitted by the Chairman (PBC.20/L.3), the Committee adopted the following conclusion:

##### **Conclusion 2004/3 FINANCIAL SITUATION OF UNIDO**

The Committee recommended to the Industrial Development Board the adoption of the following draft decision:

“The Industrial Development Board:

“(a) Takes note of the information provided in document IDB.29/8-PBC.20/8;

“(b) Urges those Member States and former Member States that have not yet paid their assessed contributions, including advances to the Working Capital Fund and prior years’ arrears, to do so without delay;

“(c) Requests the Director-General to pursue his efforts and contacts with Member States to effect the collection of arrears.”

##### **B. Mobilization of financial resources (item 6)**

21. On 8 and 9 September, the Committee considered a report by the Director-General on the mobilization of financial resources (PBC.20/4), information in the *Annual Report of UNIDO 2003* on perspective four: consolidation of funding performance—funds mobilization (PBC.20/2, chap. VI) and a conference room paper on projects approved under the Industrial Development Fund, trust funds and other voluntary contributions in 2003 (PBC.20/CRP.2).

22. On 9 September, after consideration of a draft conclusion on the *mobilization of financial resources*, submitted by the Chairman (PBC.20/L.4), the Committee adopted the following conclusion:

##### **Conclusion 2004/4 MOBILIZATION OF FINANCIAL RESOURCES**

The Committee recommended to the Industrial Development Board the adoption of the following draft decision:

“The Industrial Development Board:

“(a) Takes note of the information contained in document IDB.29/4-PBC.20/4;

“(b) Decides to delegate to the Director-General the authority to approve projects for financing under the Industrial Development Fund in 2005 and 2006 in accordance with the priorities defined in the medium-term programme framework, 2004-2006 (GC.10/14);

“(c) Encourages Member States and other donors to increase their voluntary contributions to UNIDO;

“(d) Also encourages all donors to consider contributing programmable funds, specifically to enable UNIDO to implement the integrated programmes in a coordinated manner and achieve the synergy and increased impact envisaged in the integrated programme concept;

“(e) Encourages the Secretariat and the Member States to work closely together on selected priority themes, with a view to promoting and mobilizing funding for the implementation of these important

activities in response to international development priorities.”

**V. REPORT OF THE EXTERNAL AUDITOR,  
FINANCIAL PERFORMANCE REPORT  
AND PROGRAMME PERFORMANCE

(item 3); TRANSITION TO A SINGLE-

23. The Committee decided to discuss simultaneously items 3 and 4.

**A. Report of the External Auditor, financial

2002-2003 (item 3)**

24. On 9 September, the Committee considered the report of the External Auditor on the accounts of the United Nations Industrial Development Organization and of the Industrial Development Fund for the financial period 2002-2003 ended 31 December 2003 (PBC.20/3), the financial performance report for the biennium 2002-2003 submitted by the Director-General (PBC.20/5) and the *Annual Report of UNIDO 2003* (PBC.20/2 and Add.1).

25. On 9 September, after consideration of a draft conclusion on the *Report of the External Auditor, financial performance report and programme performance report for the biennium 2002-2003*, submitted by the Chairman (PBC.20/L.6), the Committee adopted the following conclusion:

The Committee recommended to the Industrial Development Board the adoption of the following draft decision:

“The Industrial Development Board:

“(a) Takes note of the report of the External Auditor on the accounts of the United Nations Industrial Development Organization and of the Industrial Development Fund for the financial period 2002-2003 ended 31 December 2003 as contained in document IDB.29/3-PBC.20/3, as well as the financial performance report for the biennium 2002-2003

(IDB.29/5-PBC.20/5) and the *Annual Report of UNIDO 2003* (including programme performance report for 2003) (IDB.28/2-PBC.20/2);

“(b) Recognizes the important contribution the External Auditor makes to the improvement of UNIDO’s overall financial management and performance and takes note of his recommendations in this regard;

“(c) Expresses its gratitude to the External Auditor for his valuable report for the fiscal period 2002-2003;

“(d) Requests the Director-General to implement the recommendations of the External Auditor fully and without delay and to report thereon to the Industrial Development Board at its thirtieth session.”

B. Transition to a single-currency system (item 4)

26. On 9 September, the Committee took note of the entry contained in the annotated agenda (PBC.20/1/Add.1) on item 4.

**VI. DATE OF THE TWENTY-FIRST SESSION

27. On 9 September, the Committee took note of the entry contained in the annotated agenda (PBC.20/1/Add.1) on the dates reserved for the policy-making organs of UNIDO in 2004 and 2005.

28. On 9 September, after consideration of a draft conclusion on the *date of the twenty-first session*, submitted by the Chairman (PBC.20/L.5), the Committee adopted the following conclusion:

**Conclusion 2004/7 DATE OF THE TWENTY-  
FIRST SESSION**

The Programme and Budget Committee decided to hold its twenty-first session from 10 to 12 May 2005.

**VII. ADOPTION OF THE REPORT (item 11)  
AND CLOSURE OF THE  
TWENTIETH SESSION**

29. On 9 September, the Committee adopted the draft report of its twentieth session (PBC.20/L.1) on the understanding that the Rapporteur would be entrusted with the task of finalizing the report.
