## Preparatory arrangements for the thirteenth session of the General Conference

### Report by the Director-General

Provides information on developments subsequent to the adoption of Board decision IDB.34/Dec.9.

1. At its resumed thirty-fourth session on 2 September 2008, the Board decided to accept the kind offer of the Government of Nigeria to host the thirteenth session of the UNIDO General Conference in Abuja, Nigeria from 7 to 11 December 2009 (decision IDB.34/Dec.9 refers). In accordance with the same decision the Secretariat continued consultations with the Government.
2. Since the Board took its decision, the onset of the global financial crisis has created a challenging environment for many governments. Under such difficult circumstances, a meeting of the Enlarged Bureau of the Board on 17 November 2008 considered a decision by the Government of Nigeria to defer its interest in hosting the General Conference. A letter to the same effect by the Minister of Foreign Affairs of Nigeria, H.E. Mr. Ojo Maduekwe, dated 14 November 2008, is included in the annex.
3. Enlarged Bureau members expressed their understanding for the timely decision taken by the Government of Nigeria. The Bureau furthermore agreed to recommend reconsidering Board decision IDB.34/Dec.9.
