### Introduction

1. The report of the Industrial Development Board on the work of its twenty-eighth session is presented to the General Conference in accordance with Article 9.4 (c) of the Constitution. The summary records of the Board (IDB.28/SR.1-6), where the details of the proceedings are contained, form an integral part of the present report.

### I. ORGANIZATIONAL AND PROCEDURAL MATTERS

3. The twenty-eighth session of the Board was held at UNIDO Headquarters, Vienna International Centre, from 25 to 27 May 2004 (six plenary meetings—see IDB.28/SR.1-6).

#### Participation

4. All 53 members of the Board were represented at the session: Algeria, Austria, Belgium, Bolivia, Brazil, Chile, China, Colombia, Côte d'Ivoire, Cuba, Denmark, Ecuador, Egypt, France, Germany, Ghana, Greece, Hungary, India, Indonesia, Iran (Islamic Republic of), Italy, Japan, Jordan, Kenya, Lesotho, Luxembourg, Mexico, Morocco, Netherlands, Nigeria, Norway, Pakistan, Philippines, Poland, Republic of Korea, Russian Federation, Saudi Arabia, Senegal, Slovakia, South Africa, Spain, Sudan, Switzerland, Syrian Arab Republic, Thailand, Tunisia, Turkey, Ukraine, United Kingdom of Great Britain and Northern Ireland, Uruguay, Venezuela, Zimbabwe.

5. The following 45 Member States of UNIDO also participated in the session: Afghanistan, Albania, Angola, Argentina, Azerbaijan, Belarus, Bosnia and Herzegovina, Bulgaria, Burkina Faso, Cape Verde, Croatia, Cyprus, Czech Republic, Democratic People's Republic of Korea, Ethiopia, Finland, Gabon, Guatemala, Iraq, Ireland, Lebanon, Libyan Arab Jamahiriya, Lithuania, Madagascar, Malta, Monaco, Namibia, New Zealand, Nicaragua, Oman, Panama, Paraguay, Peru, Rwanda, Serbia and Montenegro, Sierra Leone, Slovenia, Sri Lanka, Sweden, Tajikistan, the former Yugoslav Republic of Macedonia, United Arab Emirates, Uzbekistan, Viet Nam, Yemen.

6. Palestine participated as observer.

7. The Sovereign Military Order of Malta participated as observer.

8. The following United Nations body was represented: United Nations Office on Drugs and Crime.

9. The following United Nations specialized agencies were represented: Food and Agricultural Organization of the United Nations, International Atomic Energy Agency.

10. The following other intergovernmental organizations were represented: European Union, International Centre for Genetic Engineering and Biotechnology, International Institute of Refrigeration, League of Arab States, Organization of the Islamic Conference.

11. The following non-governmental organizations were represented: Association of former United Nations Industry and Development Experts, Austrian Senior Experts Pool, Austro-Arab Chamber of Commerce, Austro-Egyptian Chamber of Commerce, Institut Supérieur de Gestion, International Congress of Industrialists and Entrepreneurs, International Federation for Medical and Biological Engineering, International Organization for Standardization, International Organization of Employers, Mountain Unlimited, Society for International Development, Soroptimist International, Volunteers Association for International Service, World Association for Small and Medium Enterprises, World Confederation of Labour.

#### Opening of the session

12. The twenty-eighth session of the Board was declared open by the President of the twenty-seventh session, Mr. R. González Aninat (Chile).

#### Officers of the session

13. In accordance with rule 23 of its rules of procedure, the Board elected by acclamation Mr. O. Zniber (Morocco) as President; Mr. T. Stelzer (Austria), Mr. M. Kalinin (Russian Federation) and Mr. S. Ariyaprichya (Thailand) as Vice-Presidents and Mr. G. Alvarez Goyoaga (Uruguay) as Rapporteur.

15. The Board adopted a proposal by the President to ensure the maximum utilization of available conference-servicing resources (see annex I, decision IDB.28/Dec.1, IDB.28/SR.1, paras. 80 and 81).

16. The Board decided to set up informal, in-session consultations with the aim of facilitating the drafting of decisions and entrusted Vice-President Mr. T. Stelzer (Austria) (see IDB.28/SR.2, paras. 1 and 2) to chair those consultations.

## **II. ANNUAL REPORT OF THE DIRECTOR-GENERAL FOR 2003 ON THE ACTIVITIES OF THE ORGANIZATION (item 3)**

17. Under item 3, the Board had before it the Annual Report of the Director-General for 2003 on the activities of the Organization (IDB.28/2) including the programme performance report and the list of technical

cooperation activities (IDB.28/2/Add.1). The debate on this item is reflected in summary records IDB.28/SR.2, paragraphs 35 to 105 and IDB.28/SR.3, paragraphs 1 to 81. At the proposal of the President, the Board took note of the documentation provided by the Secretariat (IDB.28/SR.6, paras. 5 and 6).

## **III. OUTCOME OF THE INFORMAL CONSULTATIVE GROUPS (item 4)**

18. Under item 4, the Board had before it a report by the Director-General on the outcome of the informal consultative groups (IDB.28/7) and two notes by the Secretariat IDB.28/6 and IDB.28/CRP.6. The debate on this item is reflected in summary records IDB.28/SR.3, paragraphs 82 to 116 and IDB.28/SR.4, paragraphs 13 to 26. At the proposal of the President, the Board took note of the documentation provided by the Secretariat (IDB.28/SR.6, paras. 7 and 8).

## **IV. MEDIUM-TERM PROGRAMME FRAMEWORK, 2004-2007 (item 5), INCLUDING: APPLICATION OF THE STRATEGIC GUIDELINES "TOWARDS IMPROVED UNIDO PROGRAMME DELIVERY" (item 5 (a)); SOUTH-SOUTH COOPERATION (item 5 (b)); UNIDO ACTIVITIES IN COUNTRIES EMERGING FROM CRISIS SITUATIONS (item 5 (c)); DECENTRALIZATION (item 5 (d))**

19. Under item 5, the Board had before it a report by the Director-General on the implementation of the medium-term programme framework, 2004-2007 (including the application of the Strategic Guidelines) (IDB.28/3), a note by the Secretariat (IDB.28/CRP.9), information on South-South cooperation as contained in the *Annual Report 2003* (IDB.28/2, chap. IV.G), a report by the Director-General on UNIDO activities in countries emerging from crisis situations (IDB.28/5), a note by the Secretariat (IDB.28/CRP.4) and two notes by the Secretariat on decentralization (IDB.28/6) and (IDB.28/CRP.7). The debate on item 5 is reflected in summary record IDB.28/SR.4, paragraphs 27 to 141. The Board considered a draft decision submitted by the President (IDB.28/L.9) and adopted decision IDB.28/Dec.2 (see annex I).

## **V. FINANCIAL SITUATION OF UNIDO (item 6); TRANSITION TO A SINGLE-CURRENCY SYSTEM (item 7)**

20. The Board decided to discuss simultaneously items 6 and 7. The debate on the items is reflected in summary record IDB.28/SR.4, paragraphs 142 to 154.

**A. Financial situation of UNIDO**

21. Under item 6, the Board had before it a report by the Director-General on the financial situation of UNIDO (IDB.28/10) and updated information on the financial situation of UNIDO (IDB.28/CRP.5). The Board considered two draft decisions submitted by the President (IDB.28/L.3 and IDB.28/L.8) and adopted decisions IDB.28/Dec.3 and IDB.28/Dec.4 (see annex I).

**B. Transition to a single-currency system**

22. Under item 7, the Board had before it a report by the Director-General on transition to a single-currency system (IDB.28/9). The Board considered a draft decision submitted by the President (IDB.28/L.2) and adopted decision IDB.28/Dec.5 (see annex I).

The Board considered a draft decision submitted by the President (IDB.28/L.5) and adopted decision IDB.28/Dec.6 (see annex I).

25. Under item 10, the Board took note of the entry contained in the annotated provisional agenda (IDB.28/1/Add.1). The debate on item 10 is reflected in summary record IDB.28/SR.5, paragraphs 62 to 72. The Board considered a draft decision submitted by the President (IDB.28/L.10) and adopted decision IDB.28/Dec.7 (see annex I).

**IX. MATTERS RELATED TO INTER-  
GOVERNMENTAL, NON-GOVERNMENTAL,  
GOVERNMENTAL AND OTHER  
ORGANIZATIONS (item 11)**

26. Under item 11, the Board had before it two notes by the Director-General on applications from non-governmental organizations for consultative status (IDB.28/12 and IDB.28/12/Add.1). The debate on item 11 is reflected in summary record IDB.28/SR.5, paragraphs 73 to 76. The Board considered a draft decision submitted by the President (IDB.28/L.4) and adopted decision IDB.28/Dec.8 (see annex I).

**X. PROVISIONAL AGENDA AND DATE OF

**IDB.28/Dec.2 DECENTRALIZATION**

The Industrial Development Board:

(a) Recalled that the Business Plan on the Future Role and Functions of UNIDO called for an effective decentralization of activities and strengthened field representation;

(b) Also recalled General Conference resolutions GC.10/Res.2 and GC.10/Res.10;

(c) Noted the establishment of the informal advisory group on decentralization (IDB.28/7, para. 13);

(d) Recommended to the Secretariat to take into account the conclusions of the report on the assessment/evaluation of UNIDO's field representation in order to elaborate and pursue the best option for further strengthening and rationalizing its field presence with the aim of increasing and extending its technical cooperation delivery while enhancing its participation in the United Nations system at the country level;

(e) Invited the Director-General to continue his dialogue with the United Nations Development Programme (and possibly other United Nations agencies), with a view to submitting a proposal on a potential alliance in the field and in the context of the United Nations ongoing reform process for further consideration by the Industrial Development Board and/or the General Conference. The future field representation scheme should preserve and build upon UNIDO's achievements in the various regions. It should also:

- (i) Promote increased and extended technical cooperation delivery by UNIDO with improved efficiency and results based on the work of its most successful offices;

(ii) Increase its participation in common United Nations initiatives at the country level;

(iii) Develop synergies, inter alia between UNDP and UNIDO, while ensuring that UNIDO core competencies are respected and promoted, and that its own identity, visibility and ability to carry out its mandates are maintained;

(iv) Remain within the limits of existing budgetary resources;

(f) Recommended that UNIDO's new field presence be expanded in a carefully planned, phased-in approach.

(b) Also took note that the General Conference decided to approve articles IV (Finance), X (Programme and Budget) and XIV (Dissolution), subject to the final approval of the statute by the Industrial Development Board;

(c) Further took note that the Conference referred to the Board articles I to III, V to IX, XI to XIII and XV, with a view to their finalization and adoption;

(d) Having reviewed the matter, decided to adopt the draft statute as contained in the annex to the present decision, which would enter into effect, subject to the approval by the twenty-ninth session of the Board of the arrangements to be proposed jointly by the Government of Italy and the UNIDO Secretariat with a view to ensuring that the new statute of the ICS does not lead to any liability for UNIDO;

(e) Decided further that, pending the adoption by the UNIDO General Conference of financial regulations for the Centre, the existing financial regulations and rules of UNIDO would apply.

**ANNEX****STATUTE OF THE INTERNATIONAL CENTRE FOR SCIENCE AND HIGH TECHNOLOGY****Article I**  
*Objectives*

1. The International Centre for Science and High Technology (hereinafter referred to as "the Centre") has been established to further the action of the United Nations Industrial Development Organization (hereinafter referred to as "UNIDO") in the areas covered by Article 2 (j) of the latter's Constitution.

2. The Centre shall have the objectives conferred on the International Centre for Science and High Technology, established in 1996, namely:

(a) To further, for the benefit of developing countries, the utilization of applied science for peaceful aims, and the development of science-based technologies;

(b) To promote and stimulate high-level research with a direct involvement of developing countries' scientists; and

(c) To provide conditions and structures for the professional promotion of scientists and technicians of developing countries.

3. The languages of instruction shall, in principle, be English, French and Spanish.

#### **Article II** *Functions*

1. To fulfil the objectives mentioned in Article I, the Centre shall carry out the following main functions:

- (i) Long-term and short-term training;
- (ii) Research;
- (iii) Conduct of workshops and scientific meetings;
- (iv) Operation of a scheme of visiting scientists and associates;
- (v) Advisory services;
- (vi) Cooperation with industry;
- (vii) Cooperation with and affiliation of relevant national institutions; and
- (viii) Transfer of technologies.

2. In the performance of these functions, priority shall be given to the following subject areas:

- (i) Pure and applied chemistry;
- (ii) Earth, environmental and marine sciences and technologies; and
- (iii) High technology and new materials.

3. The work shall be organized in such ways as will facilitate integration between the above areas, improving the related strategies.

#### **Article III** *Legal Status*

1. The Centre, established within the constitutional framework of UNIDO as a subsidiary organ, is a non-profit-making scientific institution.

2. The Centre shall possess such legal capacity as may be necessary or desirable for the achievement of its purposes. In particular, it shall have the capacity:

- (a) To contract;
- (b) To acquire and dispose of movable and immovable property; and
- (c) To institute and defend legal proceedings.

3. The Centre shall enjoy such privileges and immunities as may be necessary for the fulfilment of its purposes. These privileges and immunities shall be specified in separate arrangements.

#### **Article IV** *Finance*

1. The Centre's budget shall be financed from voluntary contributions, made in the framework of Article 16 of the Constitution, by:

- (i) Governments;
- (ii) Intergovernmental organizations;
- (iii) International non-governmental organizations; and
- (iv) Other non-governmental sources,

as well as from income earned from the sale of its publications or similar material and from the exploitation or use of intellectual and other property rights.

2. Contributions to the budget from the Government of the country in which the Centre is located (hereinafter referred to as "the host Government"), from any other Member of UNIDO or from any inter-governmental organization having relations with UNIDO under Article 19.1 (a) of the Constitution may be the subject of special agreements, on an annual or longer basis, between the governments or organizations concerned and UNIDO.

3. Financial Regulations shall be adopted by the General Conference of UNIDO for the Centre. They shall be amended, as necessary, by the General Conference on the recommendation of the Steering Committee referred to in Article V (i) or after consultation with the Steering Committee. The Financial Regulations shall make provision for the



Managing Director to issue financial rules to give effect to the provisions of the Financial Regulations. Such rules shall be communicated to the Steering Committee for approval.

4. The funds and assets of the Centre shall be administered and accounted for separately from the assets of UNIDO.

5. UNIDO shall, where necessary, provide the Centre with appropriate administrative support. The Centre shall reimburse such support at a level that shall be determined from time to time in consultations between UNIDO and the Centre.

#### **Article V**

##### *Organs*

The Centre shall comprise the following organs:

- (i) A Steering Committee;
- (ii) An International Scientific Committee;
- (iii) A Secretariat.

#### **Article VI**

##### *The Steering Committee*

1. The Steering Committee shall be responsible for the general management of the Centre. It shall submit to UNIDO an annual report on the Centre's activities.

2. The Steering Committee shall be composed of:

- (i) One representative of each Government for which a special agreement referred to in Article IV.2 is in force;
- (ii) One further representative of the host Government, who shall be a qualified scientist;
- (iii) The Director-General of UNIDO or his representative;
- (iv) One further representative of UNIDO; and
- (v) Representatives of other Governments of Members selected by the Industrial Development Board in the number and for the period decided by it, with due regard to ensuring an equitable geographical representation of Governments on the Steering Committee.

3. A representative of each organization for which a special agreement referred to in Article IV.2 is in force may participate in the Steering Committee with the same rights as members of that Committee except the right to vote.

4. Each Member of the Steering Committee shall have one vote. Decisions shall wherever possible be taken by consensus. Other Governments and organizations may, on the invitation of the Steering Committee, participate in its discussions as observers. The Steering Committee shall establish rules of procedure for its own functioning that are consistent with the provisions of this Statute.

5. The Director-General of UNIDO or his representative shall be the Chairperson of the Steering Committee.

6. The Steering Committee shall meet at least once a year normally at the seat of the Centre and whenever considered necessary by its Chairperson. It shall be convened by the Managing Director, who shall be its Secretary.

7. The Managing Director shall be empowered, between sessions of the Steering Committee, to deal with any matter which may be delegated to him by the Steering Committee.

#### **Article VII**

##### *The International Scientific Committee*

1. The International Scientific Committee shall reflect the relevant scientific disciplines and include an adequate number of qualified scientists and technologists from developing countries and from the host country.

2. The composition of the Committee shall be decided by the Director-General of UNIDO, taking into consideration the proposals of the Steering Committee, the Managing Director and the Rector referred to in Article VIII. The Director-General of UNIDO or his representative shall be entitled to participate in the work of the Committee.

3. The Committee shall be convened by the Managing Director at least once a year and whenever considered necessary by the Director-General of UNIDO.

4. The Committee shall review the programme and budget of the Centre from the scientific point of view and shall make comments and recommendations thereon. It shall submit an annual report to the Steering Committee.

#### **Article VIII**

##### *The Rector*

1. The members of the International Scientific Committee shall annually elect or re-elect the Rector of the Centre from among the Committee's members.

2. The Rector shall chair the International Scientific Committee, shall provide guidance on the Centre's scientific activities when so requested by the Managing Director and shall perform such other functions as are specified in this Statute or as may be requested by the Steering Committee.

**Article IX**  
*The Secretariat*

1. The Secretariat shall be headed by the Managing Director of the Centre, who shall be selected and appointed by the Director-General of UNIDO after consultation with the representatives of Governments on the Steering Committee.

2. The staff of the Centre shall be selected and appointed by the Director-General of UNIDO.

- (a) The appointment of staff will be in accordance with the provisions of the UNIDO Staff Regulations and Rules and administrative instructions;
- (b) The terms and conditions of employment will be according to the provisions of UNIDO's Staff Regulations and Rules, administrative instructions and, shall conform, as applicable, to those of the United Nations Common System as determined by the International Civil Service Commission.

3. The Managing Director:

- (a) Under the authority of the Director-General, shall act as the representative for matters relating to the Centre and shall be responsible for its administration and operations;
- (b) Shall be responsible for the selection of fellows;
- (c) Shall draw up the Centre's programme and budget in accordance with Article X; and
- (d) Shall report to the Steering Committee on the Centre's activities.

4. The Managing Director and staff of the Centre shall be paid from the Centre's funds.

5. The staff of the Centre shall be subject to the authority of the Director-General and administered by the Managing Director in the exercise of their daily functions.

6. The Managing Director shall be responsible to the Director-General of UNIDO and subject to the latter's overall authority in the exercise of the functions conferred on the Managing Director.

7. The Managing Director and the staff of the Centre shall have the status and obligations of officials of UNIDO.

8. The Steering Committee shall lay down general rules for the selection of fellows.

9. The Managing Director and the staff of the Centre shall carry out their responsibilities as international civil servants. They shall respect the international character of the Centre and ensure that the teaching given therein is objective and independent.

10. The Secretariat of the Centre shall service the Steering Committee and the International Scientific Committee.

**Article X**  
*Programme and budget*

The programme and budget of the Centre shall be drawn up by the Managing Director, after consultation with the Chairperson of the Steering Committee and the Rector and after having considered the recommendations of the International Scientific Committee. The programme and budget shall then be presented to the Steering Committee for review and adoption. The adopted budget shall be presented to UNIDO for approval.

**Article XI**  
*Cooperation with other international organizations*

The Centre may make technical arrangements with the United Nations, and with Specialized Agencies and other intergovernmental organizations, as well as with non-governmental organizations, to pursue activities in conformity with its objectives as set forth in Article I.

**Article XII**  
*Location*

The Centre shall be located in Italy on premises to be provided under a headquarters agreement between UNIDO and the Italian Government.

**Article XIII**  
*Amendment of the Statute*

This Statute may be amended at any time by the General Conference of UNIDO on the recommendation of the Steering Committee or after consultation with it.

**Article XIV**  
*Dissolution*

1. The Centre may be dissolved by the General Conference of UNIDO.

2. In the event of the Centre being dissolved, its remaining funds and assets shall be used in accordance with instructions to be issued by the General Conference of UNIDO, except to the extent that the disposal of the unspent balances of any contributions made to or for the Centre may be subject to conditions attached by the donors and accepted by the Centre or UNIDO at the time such contributions were made.

**Article XV**  
*Effective date*

This Statute shall formally enter into effect on the date decided by the General Conference of UNIDO or the Industrial Development Board.
