#### **GC.9/Dec.10 SCALE OF ASSESSMENTS OF MEMBER STATES**

*The General Conference:*

(a) Took note of documents IDB.24/5, GC.9/10 and of Board decision IDB.24/Dec.5;

(b) Decided to establish a scale of assessments for the regular budget expenditures of UNIDO for the fiscal period 2002-2003 as contained in columns 5 and 6 of the annex to document IDB.24/5;

(c) Noted with appreciation that Japan had renounced its shares of the unencumbered balances of appropriations, income from new Member States, and interest income in excess of budgetary estimates;

(d) Decided, as an exceptional measure and notwithstanding the provisions of the Financial Regulations and Rules of UNIDO, that the amounts arising from paragraph (c) of the present decision should be credited against the assessed contribution of Member States, as shown in the annex to the present decision;

(e) Also decided that the remaining share of the Member State referred to in paragraph (c) of the present decision should be used for technical cooperation activities of UNIDO;

(f) Strongly encouraged other Member States to consider renouncing voluntarily their shares of the balances and income referred to in paragraph (c) above, for the regular budget and/or for technical cooperation activities of UNIDO, at the earliest possible opportunity;

(g) Notwithstanding financial regulations 4.2(b) and 4.2(c), called upon the Director-General to solicit the intention of the Member States and to request them to specify the purposes for which their shares referred to in paragraph (f) above should be utilized;

(h) Requested the Director-General to report to the Industrial Development Board at its twenty-fifth session on the amounts renounced and purposes specified by Member States;

obligations by paying their assessed contributions on time, in full and without conditions, thus enabling UNIDO to execute entirely its approved budgets, and increasing funds available for the Regular Programme of Technical Cooperation.

*The General Conference:*

(a) Took note of the information provided in document GC.9/10;

(b) Urged those Member States and former Member States that had not yet paid their assessed contributions, including advances to the Working Capital Fund and prior years' arrears, to do so without delay;

(c) Requested the Director-General to pursue his efforts and contacts with Member States to effect the collection of arrears.

#### **GC.9/Dec.12 PROPOSED PAYMENT PLAN FOR UKRAINE**

*The General Conference:*

(a) Recalled the report of the open-ended discussion group on timely payment of assessed contributions (IDB.19/12 and Corr.1), in particular paragraphs 13 and 14;

(b) Also recalled Board decisions IDB.19/Dec.5 and IDB.24/Dec.3;

(c) Welcomed the commitment of Ukraine to settle its arrears;

(d) Decided to approve the payment plan negotiated with Ukraine as outlined in documents GC.9/9 and Add.1;

(e) Gave satisfaction to the request by Ukraine for the restoration of its voting rights in accordance with Article 5.2 of UNIDO's Constitution;

(f) Took note of the terms of the payment plan and encouraged Ukraine to pay regularly its instalments in line with the conditions therein.

(c) Urged Member States to pay their outstanding assessed contributions as soon as possible to minimize the need to withdraw sums to meet shortfalls in the payment of assessed contributions.

(c) Also took note that the Director-General would continue to keep extrabudgetary accounts in United States dollars, if required, but would convert all such assets, liabilities, reserves and fund balances for the purposes of the financial statements at the United Nations euro/dollar exchange rate in effect on the date of the statement;

(d) Decided to convert all dollar-based amounts of the assets, liabilities, reserves and fund balances of the General Fund, Working Capital Fund and other headquarters funds as at 31 December 2001, using the December 2001 United Nations euro/dollar exchange rate.

#### **GC.9/Dec.18 VIENNA CONVENTION ON THE LAW OF TREATIES BETWEEN STATES AND INTERNATIONAL ORGANIZATIONS OR BETWEEN INTERNATIONAL ORGANIZATIONS OF 21 MARCH 1986**

*The General Conference:*

(a) Took note of the information provided in the note by the Director-General regarding the participation by UNIDO in the Vienna Convention on the Law of

Treaties between States and International Organizations or between International Organizations of 21 March 1986 (GC.9/6);

(b) Acknowledged that the General Assembly of the United Nations by its resolution 53/100 of 8 December 1998 encouraged international organizations that had signed the Convention to deposit an act of formal confirmation of the Convention, and other international organizations entitled to do so to accede to it at an early date;

(c) Encouraged the progressive development of international law and its codification as well as the acceptance of and respect for the principles of international law which were among the purposes of the United Nations Decade of International Law;

(e) Decided to authorize the Director-General to deposit with the Secretary-General of the United Nations an instrument of accession of UNIDO to the 1986 Vienna Convention on the Law of Treaties between States and International Organizations or between International Organizations.

**DRAFT CONTRACT FOR APPOINTMENT OF  
THE DIRECTOR-GENERAL**

THIS CONTRACT is made

between the United Nations Industrial Development Organization (hereinafter called the Organization) for the one part

and Carlos Magariños (hereinafter called the Director-General) for the other part.

**WHEREAS**

The Director-General, upon recommendation of the Board, has been duly appointed by the Conference at its ninth session held in December 2001.

**IT IS HEREBY AGREED AS FOLLOWS:**

1. Term of Office

The Director-General shall be appointed for a period of four years from the eighth day of December two thousand one (2001), or until the Director-General to be appointed at the eleventh regular session of the General Conference assumes office, whichever is later.

2. Official Duty Station

The official duty station for the Director-General shall be Vienna, Austria.

3. Official Duties

In accordance with Article 11 of the Constitution of the Organization, the Director-General shall be the chief administrative officer of the Organization.

4. Privileges and Immunities

The Director-General shall enjoy all the privileges and immunities in keeping with his/her office as determined by the Constitution of the Organization, Article 21, and any relevant legal instruments already in force or to be concluded in the future.

5. Staff Regulations

The Director-General shall be subject to the Staff Regulations of the Organization, together with such amendments as may be made thereto, in so far as they are applicable to him/her.

6. Assessable Salary and Allowances

(a) The annual gross salary of the Director-General shall be US dollars two hundred and five thousand three hundred and nine (205,309), corresponding to an annual net base salary equivalent to US dollars one hundred and thirty-seven thousand four hundred and ninety-two (137,492) (dependency rate) or US dollars one hundred and twenty-two thousand two hundred and sixty-eight (122,268) (single rate) respectively. The gross and net base salary shall be adjusted whenever the General Assembly decides to adjust the gross and net base salary levels of staff in the Professional and higher categories;

(b) He shall receive post adjustment, allowances and benefits, including social security benefits, for which a staff member in the Professional category of the UNIDO Secretariat would be eligible under the Staff Regulations and Staff Rules of the Organization, provided the purpose of such emolument, allowance or benefit has not already been met by other provisions of the present contract;

(c) The Director-General shall receive a representation allowance of Austrian schillings three hundred and sixty-one thousand two hundred (361,200) per annum; as of 1 January 2002, euros twenty-six thousand two hundred and forty-nine (26,249) per annum, adjusted for the budgeted annual inflation rate, to meet his/her share of the obligations which the Organization incurs in the form of representation and hospitality expenditure;

(d) He shall receive a housing allowance amounting to Austrian schillings six hundred and eleven thousand four hundred and sixty (611,460) per annum; as of 1 January 2002, euros forty-four thousand four hundred and thirty-seven (44,437) per annum adjusted for the budgeted annual inflation rate;

(e) The above salary, allowances and benefits to which the Director-General is entitled under this agreement shall be subject to adjustment by the Board, after consultations with the Director-General, to keep them in line with those of the executive heads of other specialized agencies within the common system of the United Nations.

7. Pension Arrangements

The Director-General shall not participate in the United Nations Joint Staff Pension Fund. Instead, he/she shall have an amount equal to 15.8 per cent of pensionable remuneration, corresponding to the Organization's contribution to the Pension Fund, paid as a supplement to his/her remuneration, in lieu of participation in the Pension Fund, in accordance with General Assembly resolution 47/203.

8. Currency of Payments

Payments will be effected in the currency applicable to staff in the Professional and higher categories serving at the official duty station Vienna, Austria.

9. Notice of Resignation

The Director-General may at any time give three months' notice of resignation in writing to the Board, which is authorized to accept his resignation on behalf of the General Conference, in which case, upon expiration of such period of notice, he shall cease to be Director-General of the Organization and this contract shall terminate.

10. Entry into Force

This contract shall enter into force as of the eighth day of December 2001.

### GC.9/Res.2 MEDIUM-TERM PROGRAMME FRAMEWORK, 2002-2005

*The General Conference,*

*Recalling* its resolution GC.7/Res.1 endorsing the Business Plan on the Future Role and Functions of UNIDO, which remains the basis for the organizational and programmatic transformation of the Organization and which grouped UNIDO activities into two areas of concentration:

- (a) The strengthening of industrial capacities,
- (b) Cleaner and sustainable industrial development,

*Recalling also* that while maintaining the universal character and vocation of UNIDO, a geographical, sectoral and thematic concentration of its activities would be pursued by giving added emphasis to the following:

- (a) Services to least developed countries, in particular in Africa, with special attention to the regional and subregional level,

(b) Services in support of agro-based industries and their integration through subsectoral linkages into national industrial structures,

(c) Services in support of small and medium enterprises and their integration into national industrial structures,

*Recognizing* the importance of the proposal for the medium-term programme framework 2002-2005 as contained in document GC.9/11, which also reports on progress in implementing the Business Plan,

*Noting* the developments in the implementation of the Business Plan, as reported in documents GC.8/10, Corr.1 and 2 and GC.9/11, aware that outstanding tasks remain, partly due to resource shortages,

*Taking into account* other innovative measures undertaken to bring about the programmatic and organizational transformation of UNIDO, as covered in the annual reports since 1997,

*Acknowledging* the need for a strong UNIDO presence and capability to provide services in middle-income developing countries and in countries with economies in transition, in addition to, and not at the expense of what is being done in Africa,

*Stressing* the importance of promoting South-South collaboration and cooperation activities, taking into account the interests of all relevant actors and stakeholders,

*Acknowledging* the dynamic nature of international development issues and the need for UNIDO to adapt to the changing industrial development requirements of developing countries, in particular least developed countries and countries with economies in transition,

*Recognizing* the contribution that UNIDO can make to the realization of international development agendas and targets, especially the goals contained in the United Nations Millennium Declaration and in the final document of the Third United Nations Conference on Least Developed Countries,

*Considering* the importance of technology for industrial development, and thus the necessary transfer of technology, as an essential element for the economic growth of developing countries in their fight against poverty and for connecting with the world economy,

*Taking into account* that technical barriers to trade are an impediment in the current international trade system and therefore recognizing that technical

cooperation can help developing countries and countries with economies in transition to overcome those barriers,

*Underlining* that UNIDO should bear in mind, while implementing the Business Plan, resource constraints and the need to adhere to the principles of comparative advantage and inter-agency coordination,

*Convinced* that poverty reduction is a key development challenge and that UNIDO can do much to address it,

1. *Confirms* that in the context of the ongoing reform process, the Business Plan remains the basis for enabling UNIDO to adapt its functions and priorities and to orient its activities to the new realities of the changing global economic environment and ensure its viability and efficiency;

2. *Takes* into account the proposals contained in document GC.9/11 based on experience and the need to consider and to respond to evolving circumstances;

3. *Encourages* the Director-General, in implementing the Business Plan in the period 2002-2005, to devote particular attention to the following:

#### **A. Strengthening of Industrial Capacities**

(a) Maintain and reinforce all the sectoral priorities and activities of UNIDO as defined in the Business Plan;

(b) Assist developing countries and countries with economies in transition to build up their institutional capacities, especially those relating to the preparation and application of technical regulations and standards, and conformity assessment procedures with a view to their benefiting from improvements in market access and promoting their rapid and full integration into the multilateral trading system;

(c) Promote investment and technology transfer, inter alia, through the network of Investment and Technology Promotion Offices and investment promotion forums, and pursue sectoral interaction with the private sector and interregional cooperation;

(d) Contribute to the development of small and medium enterprises and assist Member States in the development and the implementation of effective policies, and in the establishment of a coherent set of specialized support institutions and programmes, paying special attention to rural entrepreneurship development as well as to women entrepreneurs, particularly in the poorest countries;

(e) Promote South-South cooperation and assistance, taking into account the dual role of middle-

income countries as recipients and donors, using their experience in advanced sectors to alleviate poverty in least developed countries;

(f) Promote transfer of technology with a view to enhancing the productivity, competitiveness and quality of the industrial base of all developing regions of the world, particularly in the following areas: agro-related technology, new information and communication technologies and biotechnologies, bearing in mind the special importance of biotechnology and related activities for those regions;

(g) Extend the technology foresight activities to all regions, taking into account the experience of the regional initiative in Latin America, as well as the new initiative for Central and Eastern Europe and NIS countries, which aims to address common issues related to regional development;

#### **B. Cleaner and Sustainable Industrial Development**

(a) Develop further cleaner production activities, especially in the agro-industrial sector, centred, among others, around the UNIDO/UNEP National Cleaner Production Centres, focusing on specific sub-sectors, including industrial waste and pollution control activities;

(b) Continue to focus the assistance programme on greenhouse gas reduction policies and increasing energy efficiency, as well as on renewable and alternative sources of energy in developing countries, particularly in the least developed countries and countries with economies in transition;

(c) Support programmes on environmentally sustainable industrial development strategies and technologies in agro-industrial sectors particularly textile, leather, food and wood-related activities;

(d) Assist Member States, in those aspects related to sustainable industrial development strategies and technologies, in the implementation of international instruments, such as the Stockholm Convention on Persistent Organic Pollutants, the Kyoto Protocol to the United Nations Framework Convention on Climate Change, the Cartagena Protocol on Biosafety of the Convention on Biological Diversity, inter alia, through the development of environmental norms and standards;

(e) Give special emphasis to initiatives, in coordination with other relevant actors and stakeholders, providing access to modern and efficient energy services for the poorest, with the goal of contributing to the international development targets;

(f) Continue to cooperate with the Global Environment Facility and to provide services to Member



States in all Global Environment Facility focal areas where UNIDO has a comparative advantage;

(g) Pursue activities related to the phasing-out of ozone depleting substances as defined in the Montreal Protocol;

#### C. Global Forum Activities

(a) Within each priority area, ensure that cost-effective and output-oriented analytical activities with clear objectives provide a strong analytical foundation for technical cooperation activities;

(b) Use and promote the global forum activities as an important tool to improve programmatic activities and to enhance common understanding on the contribution of industry to poverty alleviation and to the connection of national economies to the global economy;

(c) Participate, within its areas of competence, in major development conferences to make a visible and focused contribution;

#### D. Field Representation

(a) Establish an appropriate monitoring and evaluation system for the field structure;

(b) To optimize and strengthen, as appropriate, the field presence to ensure that it is well targeted, efficient and effective, and to promote regional integration through, inter alia, interaction and coordination with all relevant actors and stakeholders involved;

#### E. Human Resources Management

To encourage the further development of the Human Resources Management Framework while ensuring its effectiveness and efficiency;

4. *Requests* the Director-General to report to the Conference at its tenth session, through the Industrial Development Board, on the implementation of the present resolution.
