Organization of work

- 15. The Board adopted a proposal by the President to improve the utilization of available conference-servicing resources (see annex I, decision IDB.4/Dec.1).
- 16. The Board decided to establish two sessional open-ended groups which were to report to the President: a sessional drafting group to prepare the draft decisions on agenda items 4 to 21, under the chairmanship of Vice-President E. Ybáñez (Spain), and a sessional working group on rule 61 of the rules of procedure, under the chairmanship of Vice-President E. A. Al-Nowaiser (Saudi Arabia).
- 17. The Board also considered a draft decision submitted by the President concerning the conduct of business and rationalization of proceedings for future sessions of the Board (IDB.4/L.11) and adopted decision IDB.4/Dec.3 (see annex I). Rules of procedure

18. The Board had before it a report (IDB.4/CRP.12) of the Chairman of the open-ended working group established by the Board at its third session to review rule 61 of the rules of procedure of the Industrial Development Board (IDB.3/Dec.2). The Board also heard oral reports by the Chairman of the open-ended working groups of its third and the current sessions, T. Strulak (Poland) and E.A. Al-Nowaiser (Saudi Arabia), (see IDB.4/SR.9, paras. 18 and 19). The Board considered a text submitted by the President on behalf of the enlarged Bureau (IDB.4/SR.12, paras. 2-5) and adopted decision IDB.4/Dec.4 (see annex I).

II. ANNUAL REPORT ON THE ACTIVITIES OF THE ORGANIZATION

- 19. The debate on the annual report on the activities of the Organization covered also sub-items 5 (a) to (1) of the agenda.
- 20. The Board had before it the Annual Report of UNIDO, 1987 (IDB.4/10), a list of resolutions and decisions of relevance to UNIDO that were adopted in 1987 by the United Nations General Assembly and Economic and Social Council and the Governing Council of the United Nations Development Programme (IDB.4/CRP.3) and the documents mentioned under the special programmes below. The debate on item 5 is reflected in summary records IDB.4/SR.1-6 and IDB.4/SR.13, paragraphs 20-21.

A. Industrial Development Decade for Africa

21. The Board had before it a note by the Director-General containing a progress report on the implementation of the programme of the Industrial Development Decade for Africa (IDB.4/11), the annual report (IDB.4/10, chap. IV, paras. 1-12) and a report by the Director-General on institutional arrangements for Africa (IDB.4/7). The Board considered a draft decision submitted by the President (IDB.4/L.10) and adopted decision IDB.4/Dec.5 (see annex I).

B. UNIDO contribution to the implementation of the United Nations Programme of Action for African Economic Recovery and Development 1986-1990

22. The Board had before it a report by the Secretariat on the review and appraisal of the contribution of UNIDO to the implementation of the United Nations Programme of Action for African Economic Recovery and Development 1986-1990 (UNPAAERD) (IDB.4/15) and a conference room paper containing the contribution of UNIDO to the report of the United Nations Secretary-General on the mid-term review of the implementation of UNPAAERD IDB.4/CRP.5). The Board considered a draft decision submitted by the President (IDB.4/L.8) and adopted decision IDB.4/Dec.6 (see annex I).

C. Restructuring of world industrial production and redeployment

23. The Board had before it a report by the Director-General (IDB.4/28). The Board considered a draft decision submitted by the President (IDB.4/L.5) and adopted decision IDB.4/Dec.7 (see annex I).

D. System of Consultations

24. The Board had before it the annual report (IDB.4/10, chap. III, paras. 2-17), a progress report for the period May 1987 to June 1988 submitted by the Director-General (IDB.4/14), proposals by the Director-General for the programme of Consultations for the 1990-1991 biennium (IDB.4/18) and reports on the following Consultations: First Consultation on the Fisheries Industry (ID/350); Second Consultation on the Training of Industrial Manpower (ID/353); 'hird Consultation on the Pharmaceutical Industry (ID/356); First Consultation on the Non-Ferrous Metals Industry (ID/357). The Board considered a draft decision submitted by the President (IDB.4/L.14) and adopted decision IDB.4/Dec.8 (see annex I).

E. Industrial Investment Programme

25. The Board had before it the annual report (IDB.4/10, chap. III, paras. 43-61), and a report by the Secretariat (IDB.4/33 and Add.1). The Board considered a draft decision submitted by the President (IDB.4/L.24) and adopted decision IDB.4/Dec.9 (see annex I).

F. Senior Industrial Development Field Advisers, interregional and regional advisers

26. The Board had before it the annual report (IDB.4/10, chap. VI, paras. 14-22), a report of the open-ended inter-sessional working group on SIDFAs (IDB.4/CRP.1) and a note by the Director-General on the SIDFA programme (IDB.4/35). The Board also had before it reports by the Director-General on interregional advisers (IDB.4/22) and on regional

advisers (IDB.4/26). The Board considered a draft decision contained in document IDB.4/CRP.1 and a draft decision submitted by the President (IDB.4/L.3) and adopted decisions IDB.4/Dec.10 and IDB.4/Dec.11 (see annex I). For statements made in connection with the adoption of the two decisions, see summary record IDB.4/SR.12, paragraphs 35-39, 43 and 46.

G. Progress of industrialization of the least developed countries

27. The Board had before it the annual report (IDB.4/10, chap. IV, paras. 13-17) and a report by the Director-General (IDB.4/31). The Board considered three draft decisions submitted by the President (IDB.4/L.4, IDB.4/L.6 and IDB.4/L.7) and adopted decisions IDB.4/Dec.12, IDB.4/Dec.13 and IDB.4/Dec.14 (see annex I).

H. Progress in the field of industrial co-operation among developing countries

28. The Board had before it the annual report (IDB.4/10, chap. IV, paras. 18-24) and a report by the Director-General (IDB.4/30). The Board considered a draft decision submitted by the Group of 77 (IDB.4/L.46) with an amendment and adopted decision IDB.4/Dec.15 (see annex I). For statements made in connection with the adoption of the decision, see summary record IDB.4/SR.13, paragraph 4.

I. <u>Technical assistance to the Namibian people</u>

29. The Board had before it a report by the Director-General (IDB.4/8). The Board considered a draft decision submitted by the President (IDB.4/L.13) and adopted decision IDB.4/Dec.16 (see annex I).

J. <u>Technical assistance to the Palestinian people</u>

30. The Board had before it a report by the Director-General (IDB.4/13). The Board considered a draft decision submitted by the Group of 77 (IDB.4/L.22). A roll-call vote was taken, at the request of the representative of the United States of America. By 33 votes to 1, with 11 abstentions, decision IDB.4/Dec.17 was adopted (see annex I and IDB.4/SR.13, paras. 8-11). For statements made in connection with the adoption of the decision, see summary record IDB.4/SR.13, paragraphs 12-15.

K. Technical assistance to the South African national liberation movements recognized by the Organization of African Unity

31. The Board had before it a report by the Director-General (IDB.4/19). The Board considered a draft decision submitted by the President (IDB.4/L.12) and adopted decision IDB.4/Dec.18 (see annex I).

L. UNIDO contributions to environment and industrial development

32. The Board had before it a report by the Director-General (IDB.4/16 and Add.1). The Board considered a draft decision submitted by the President (IDB.4/L.18) and adopted decision IDB.4/Dec.19 (see annex I).

III. DEVELOPMENT AND TRANSFER OF TECHNOLOGY, INCLUDING THE INDUSTRIAL AND TECHNOLOGICAL INFORMATION BANK

33. The Board had before it the annual report (IDB.4/10, chap. III, paras. 18-42), and reports by the Director-General on implementation of the programmes for the development and transfer of technology (PBC.4/4, IDB.4/25 and Add.1) and on a policy framework of the development of human resources and technological capabilities for industrial development (IDB.4/5). The Board also had before it conclusion 1988/12 of the Programme and Budget Committee (PBC). The debate on the subject is reflected in summary record IDB.4/SR.6, paragraphs 36-111 and annex. The Board considered two draft decisions submitted by the President (IDB.4/L.9 and IDB.4/L.15) and adopted decisions IDB.4/Dec.20 and IDB.4/Dec.21 (see annex I). For statements made in connection with the adoption of decision IDB.4/Dec.21, see summary record IDB.4/SR.13, paragraph 26.

IV. UNIDO'S CO-ORDINATION WITH OTHER INTERNATIONAL ORGANIZATIONS

34. The Board had before it the annual report (IDB.4/10, chap. VI, paras. 1-7), a report by the Director-General on the co-ordinating role of UNIDO in the field of industrial development (IDB.4/9) and a note by the Director-General on the cross-organizational programme analysis on industrial development (IDB.4/CRP.14). The debate on the subject is reflected in summary records IDB.4/SR.6, paragraphs 112-113 and IDB.4/SR.7, paragraphs 4-30. The Board considered a draft decision submitted by the President (IDB.4/L.41) and adopted decision IDB.4/Dec.22 (see annex I).

V. EVALUATION ACTIVITIES OF UNIDO

35. The Board had before it the annual report of UNIDO (IDB.4/10, chap. V, paras. 1-11) and a note by the Director-General (IDB.4/24). The debate on the subject is reflected in summary records IDB.4/SR.7, paragraphs 31-50 and IDB.4/SR.8, paragraphs 24-38. The Board considered a draft decision submitted by the President (IDB.4/L.19) and adopted decision IDB.4/Dec.23 (see annex I).

VI. INTEGRATION OF WOMEN IN DEVELOPMENT

36. The Board had before it the annual report of UNIDO (IDB.4/10, chap. IV, paras. 25-27) and a report by the Director-General (IDB.4/27). The debate on the subject is reflected in summary record IDB.4/SR.7, paragraphs 51-86. The Board considered a draft decision submitted by the President (IDB.4/L.1) and adopted decision IDB.4/Dec.24 (see annex I).

VII. REPORT OF THE PROGRAMME AND BUDGET COMMITTEE

37. The Board had before it the PBC report on the work of its fourth session (IDB.4/4), in particular those conclusions drawn to its attention in paragraph 7 of document IDB.4/4 and a statement by the Director-General (IDB.4/CRP.7). The debate on the subject is reflected in summary records

IDB.4/SR.9, paragraphs 46-63 and IDB.4/SR.10, paragraphs 1-51, except for the debate on the medium-term plan, 1990-1995, which is reflected in summary record IDB.4/SR.10, paragraphs 52-118.

A. Scale of assessments for apportionment of the regular budget expenses of UNIDO and Working Capital Fund

38. The Board had before it PBC conclusion 1988/4, a note by the Secretariat (PBC.3/4), a status report of assessed contributions paid to the regular budget and of advances to the Working Capital Fund as of 31 July 1988 (IDB.4/36, annexes I and II) and an update of the status report (IDB.4/CRP.6). The Board considered a draft decision submitted by the President (IDB.4/L.16) and adopted decision IDB.4/Dec.25 (see annex I).

B. <u>Financial performance report and programme performance report</u>

39. The Board had before it PBC conclusions 1988/5(and 1988/10, a programme performance report for the biennium 1986-1987 submitted by the Director-General to the PBC (PBC.4/6) and supplemented by document IDB.4/37, the report of the External Auditor on the accounts of UNIDO and of IDF for the financial period 1986-1987 ended 31 December 1987 (IDB.4/3 and Corr.1) and four conference room papers containing statements by the Director-General (IDB.4/CRP.8, 9, 10 and 11). The Board considered a draft decision submitted by the President (IDB.4/L.17) and adopted decision IDB.4/Dec.26 (see annex I).

C. Medium-term plan, 1990-1995

40. The Board had before it PBC conclusion 1988/11, the revised proposals by the Director-General for the draft medium-term plan (PBC.4/3), a preview of the first biennium 1990-1991 as proposed by the Director-General (PBC.4/3/Add.1), a note by the Director-General containing preliminary indicative figures of 1990-1991 resources (PBC.4/3/Add.2 and Corr.1) and a summary of views expressed by Member States (IDB.4/32). The Board considered a draft decision submitted by the President (IDB.4/L.20) with an amendment and adopted decision IDB.4/Dec.2? (see annex I).

D. Financial situation of UNIDO, including the rationalized organizational structure of UNIDO

41. The Board had before it a report by the Director-General on the financial situation of UNIDO as of 31 July 1988 (IDB.4/36) and updates as of 30 September 1988 (IDB.4/CRP.6 and IDB.4/CRP.15), a statement by the Director-General (IDB.4/CRP.11), PBC conclusions 1988/6 and 1988/8, proposals by the Director-General for a programme for repayment of the United Nations loan to UNIDO (PBC.4/10) and a report by the Director-General on the organizational structure of UNIDO (PBC.4/11). The Board considered two draft decisions submitted by the President (IDB.4/L.23 and IDB.4/L.25) and adopted decisions IDB.4/Dec.28 and IDB.4/Dec.29 (see annex I).

E. Industrial Development Fund

42. The Board had before it PBC conclusion 1988/9, a report submitted by the Director-General to the PBC (PBC.4/5), a list of projects approved in 1987 under the Industrial Development Fund (PBC.4/CRP.1)

and the programme for 1989 and plan for 1989-1990 (PBC.4/CRP.2). The Board considered a draft decision submitted by the President (IDB.4/L.26) with an amendment and adopted decision IDB.4/Dec.30 (see annex I).

VIII. PERSONNEL MATTERS

43. IDB.4/Dec.4 RULES OF PROCEDURE

The Industrial Development Board formally adopted rule 61 of its rules of procedure, to read as follows:

Rule 61

Procedure for the appointment of the Director-General

1. Except as otherwise provided herein, the rules covering elections in the Board, as appropriate, shall apply.

- 2. A candidate for the post of Director-General shall be nominated in writing by his/her Government to the President of the Board. To be eligible for consideration, nominations of candidates must be received by the President of the Board at the latest two months prior to the opening date of the last regular session of the Board before the session of the Conference which is to appoint the Director-General. The President shall request the Secretariat to circulate such candidatures to all Members without delay. A candidature may be withdrawn at any stage by the candidate or by the nominating Government.
- 3. The consideration by the Board of the nominations shall be in private meetings.
- 4. All decisions as to candidates shall be taken by secret ballot.
- 5. A first series of ballots, not exceeding the number of candidates, shall be taken among all the candidates. If any candidate receives a two-thirds majority of the votes of all members of the Board, that candidate shall be recommended to the Conference.
- 6. If no candidate is recommended on the basis of the first series of ballots, after appropriate consultations a second series shall be held among all the candidates, with a two-thirds majority of the members present and voting required for a recommendation. After each ballot, the candidate receiving the fewest votes shall be removed from consideration during the remainder of the second series of ballots and balloting shall continue until no more than two candidates remain, whereupon no more than two further ballots shall be taken.
- 7. If no candidate is recommended on the basis of the second series of ballots, after appropriate consultations a third series shall be held among all the candidates, with a simple majority of all members of the Board required for a recommendation. After each ballot, the candidate receiving the fewest votes shall be removed from consideration during the remainder of the third series of ballots and balloting shall continue until no more than two candidates remain, whereupon no more than two further ballots shall be taken.
- 8. If no candidate is recommended on the basis of the third series of ballots, a fourth series of no more than three ballots shall be held between the two remaining candidates, with a simple majority of the members present and voting required for a recommendation.
- 9. If no candidate is recommended on the basis of the fourth series of ballots, additional candidates may then be nominated. The process of balloting as described in paragraphs 5 to 8 above shall be followed again.

The Industrial Development Board:

Industrial Development Decade for Africa (IDDA), the African Memorandum on Industrial Development in Africa and institutional arrangements, respectively;

- (i) Reiterated the request to African countries by the ECA Conference of Ministers to provide the necessary information to the secretariats of OAU, ECA and UNIDO to permit the completion of the progress report in respect of the main actions taken by African countries in the implementation of IDDA;
- (j) Endorsed the recommendation, in PBC conclusion 1988/11, paragraph (e), that, following the evaluation of the programme for IDDA, a special action programme for Africa, including the possibility of a second industrial development decade for Africa, be included in the proposed programme and budgets for the 1990-1991 biennium, bearing in mind Annex II, Section B of the Constitution of UNIDO;
- (k) Requested the Director-General, in the light of paragraph (j) above, to ensure, in the preparation of the programme and budgets for the 1990-1991 biennium, that the identity of a special programme of action for Africa is instituted in the budget along with improved and strengthened institutional arrangements that ensure effective co-ordination in the implementation and in the monitoring of the programme;
- (1) Requested the Director-General of UNIDO to continue co-operation with the secretariats of OAU and ECA in the monitoring and implementation

of the programme for IDDA, as well as its evaluation;

(m) Requested the Director-General of UNIDO to present to the Board, at its fifth session, a progress report on the implementation of the programme for IDDA.

- (b) Reaffirmed the need to strengthen the SIDFA programme in order to provide the developing countries with efficient advice in the industrial sector:
- (c) Requested the Director-General to provide in the future agreement on the role of UNIDO as an executing agency for UNDP-assisted technical co-operation projects that the Resident Representative of UNDP shall continue to represent the Organization (UNIDO) at the country level and supply the necessary support services for all activities carried out by UNIDO;
- (d) Acknowledged, after the conversion of UNIDO into a specialized agency, the need to revise the current "Memorandum of agreement concerning the establishment of a UNIDO field service at the

country level to be integrated within UNDP field offices" of 3 October 1967 (ID/B/22, annex 2);

- (e) Requested the Director-General to undertake negotiations with UNDP to revise the above-mentioned Memorandum on SIDFAs taking into account in particular the following points:
 - (i) The role of the Resident Representatives of UNDP as United Nations Resident Co-ordinators;
 - (ii) The SIDFAs, in their country or countries of assignment, shall be Senior Advisers and Deputies to the respective Resident Representatives of UNDP for the industrial sector of the UNDP country programme;
 - (iii) The SIDFAs shall receive instructions from UNIDO and shall report directly to UNIDO concerning matters pertaining to the formulation, implementation and evaluation of UNIDO-assisted projects and in other matters of direct concern to the Organization, including their function as the principal channel of communication between UNIDO and the respective Government or Governments in such matters;
 - (iv) The core functions listed in paragraph 6 of document IDB.3/21, supplemented by the requirements of each individual post, shall characterize the task of the SIDFAs;
 - (v) The SIDFAs should be recruited from among the most qualified candidates, including UNIDO Headquarters staff members and present or former project chief technical advisers:
 - (vi) The SIDFAs shall be appointed by the Director-General of UNIDO, after consultation with the host Government;
 - (vii) A procedure shall be established for the settlement of issues arising between the Resident Representative of UNDP and the SIDFA;
 - (viii) The duration of the Memorandum shall be related to the participation of UNDP in the SIDFA programme;
- (f) Requested the Director-General to present to the Board in 1990, through the Programme and Budget Committee, a proposal for a long-term financing scheme for the SIDFA programme, including, after consultations with the Administrator of UNDP, UNDP financing;
- (g) Invited Governments to provide funds for the SIDFA programme on a voluntary basis, and recalled paragraph 3 of the UNDP Governing Council decision 84/41 on the sharing of the local cost of the SIDFA offices;
- (h) Commended the UNIDO Junior Professional Officer (JPO) programme and requested donor Governments to continue giving their support to it;
- (i) Requested the Director-General to submit a report to the Board at its fifth session on the implementation of the present decision.

- (iii) To draw up, on the basis of (i) and (ii) above, an immediate action programme to assist Bangladesh in the rehabilitation of the flood-affected industries through the Special Industrial Services programme, the country programme of the United Nations Development Programme for Bangladesh, the Industrial Development Fund of UNIDO, special contributions from Member States and trust fund resources;
- (e) Appealed to donor countries who might be in a position to do so, to make generous contributions for the rehabilitation of the flood-affected industries in Bangladesh.
