- 15. The Board adopted a proposal by the President to improve the utilization of available conference-servicing resources (see annex I, decision IDB.5/Dec.1).
- 16. The Board decided to set up in-session consultations among its members with the aim of facilitating the drafting of decisions and entrusted Vice-President R. WOTAVA (Austria) to chair these consultations.
 - II. UNIDO ACTIVITIES IN 1988 AND EARLY 1989
- 17. The Board decided to discuss simultaneously items 4 (Annual Report by the Director-General on UNIDO activities for 1988), 5 (UNIDO technical co-operation activities in 1988) and 6 (Progress report for 1989, including major programmes and activities of UNIDO and follow-up to the fourth session of the Board). The debate on the three subjects is reflected in the summary records IDB.5/SR.2 - IDB.5/SR.5.
 - Annual report by the Director-General on UNIDO activities for 1988 and progress report for 1989, including major programmes and activities of UNIDO and follow-up to the fourth session of the Board
- 18. The Board had before it the Annual Report of UNIDO, 1988 (IDB.5/10); an addendum to the Report, containing an up-date for the period January to April 1989 (IDB.5/10/Add.1 and Corr.1); proposals by the Director-General for a programme of Consultations for the biennium 1992-1993 (IDB.5/18

and Corr.1); the report on the First Interregional Consultation on the Food-Processing Industry, with Emphasis on Sugar-cane Processing (ID/362); the report on the Regional Consultation on the Phosphatic Fertilizers and Pesticides Industries in Africa (ID/365); a report by the Director-General on Investment Promotion Services (IDB.5/19); a note by the Director-General on the UNIDO programme on the environment (IDB.5/CRP.5); and a summary of the report on the evaluation of the System of Consultations, prepared by the Secretariat (IDB.5/CRP.7).

19. The Board considered draft decisions submitted by the President on the following topics: technical assistance to the South African national liberation movements recognized by the Organization of African Unity (IDB.5/L.1); technical assistance to the Namibian people (IDB.5/L.2); integration of women in industrial development (IDB.5/L.3); economic and technical co-operation among developing countries (IDB.5/L.4); industrialization of the least developed countries (IDB.5/L.5/Rev.1); Industrial Development Decade for Africa (IDB.5/L.20); National Committees for UNIDO (IDB.5/L.6); Investment Promotion Services (IDB.5/L.14); programmes and activities of UNIDO (IDB.5/L.21); System of Consultations (IDB.5/L.22); evaluation of UNIDO programmes and activities (IDB.5/L.23); and UNIDO technical co-operation activities (IDB.5/L.29). The Board adopted decisions IDB.5/Dec.2 - IDB.5/Dec.12 (see annex I). The Board also endorsed for submission to the United Nations General Assembly at its forty-fourth session the report annexed to document IDB.5/CRP.5 entitled "Achieving sustainable development; UNIDO programme on the environment", took note of the reports of the Consultations held in 1988 (ID/362 and ID/365), and took note of the signing of a "Memorandum of understanding concerning the integration of the United Nations Industrial Development Organization (UNIDO) Field Service within the United Nations Development Programme (UNDP) Field Office", between UNIDO and UNDP in April 1989. B. <u>UNIDO technical co-operation</u> activities in 1988

20. The Board had before it a note by the Secretariat on UNIDO technical co-operation activities in 1988 (IDB.5/28) and a list of technical co-operation projects operational in 1988 (IDB.5/CRP.2). The Board considered a draft decision submitted by the President (IDB.5/L.29) and adopted decision IDB.5/Dec.13 (see annex I).

III. RESTRUCTURING OF WORLD INDUSTRIAL PRODUCTION AND REDEPLOYMENT

21. The Board had before it a progress report by the Director-General on UNIDO activities related to the restructuring of world industrial production and redeployment (IDB.5/15). The debate on the subject is reflected in summary record IDB.5/SR.9, paragraphs 2-47. The Board considered a draft decision submitted by the President (IDB.5/L.37) and adopted decision IDB.5/Dec.14 (see annex I).

IV. MOBILIZATION OF FINANCIAL RESOURCES FOR INDUSTRIAL DEVELOPMENT

22. The Board had before it a progress report by the Director-General on mobilization of financial resources for industrial development (IDB.5/16 - GC.3/3). The debate on the subject is reflected in summary record IDB.5/SR.9, paragraphs 34-40

and 48-64. The Board considered a draft decision submitted by the President (IDB.5/L.41) and adopted decision IDB.5/Dec.15 (see annex I).

V. THE EXTERNAL DEBT AND INDUSTRIAL DEVELOPMENT

23. The Board had before it a progress report by the Director-General on the external debt and industrial development (IDB.5/14 - GC.3/4). The debate on the subject is reflected in summary records IDB.5/SR.9, paragraphs 34-40, 66-107 and IDB.5/SR.10, paragraphs 1-26. The Board considered a draft decision submitted by the President (IDB.5/L.35). A vote was requested by the representative of the United States of America. At the request of the representative of the Philippines, the vote was taken by roll-call. By 46 votes to 1, decision IDB.5/Dec.16 was adopted (see annex I and IDB.5/SR.14, paras. 44-50). For statements made in connection with the adoption of the decision, see summary record IDB.5/SR.14, paragraphs 51-52.

VI. DEVELOPMENT AND TRANSFER OF TECHNOLOGY AND DEVELOPMENT OF HUMAN RESOURCES

24. The Board had before it the Annual Report of UNIDO, 1988 (IDB.5/10, chap. III, paras. 17-29); progress reports submitted by the Director-General on the implementation of the programme on development and transfer of technology (IDB.5/35 - GC.3/6) and on the development of human resources (IDB.5/36 -GC.3/7); and a report by the Director-General containing a comprehensive policy framework for UNIDO operations on human resource development (IDB.5/37 -GC.3/8). The debate on the subject is reflected in summary records IDB.5/SR.9, paragraphs 34-40, IDB.5/SR.10, paragraphs 27-69 and IDB.5/SR.11, paragraphs 1-26. The Board considered two draft decisions submitted by the President (IDB.5/L.31 and L.32) and adopted decisions IDB.5/Dec.17 and IDB.5/Dec.18 (see annex I).

VII. THE CO-ORDINATING ROLE OF UNIDO IN THE UNITED NATIONS SYSTEM ON INDUSTRIAL DEVELOPMENT

25. The Board had before it the Annual Report of UNIDO, 1988 (IDB.5/10, chap. VI, paras. 1-35); a report by the Director-General on mechanisms and means for analysis and monitoring of world economic developments: relevant UNIDO activities (IDB.5/17); a note by the Director-General on operational activities for development: implementation of United Nations General Assembly resolution 42/196 (IDB.5/24); a note on case studies on the functioning of operational activities for development in the United Nations system (IDB.5/24/Add.1 and Corr.1); and a report submitted by the Director-General on the cross-organizational programme analysis of the United Nations system on industrial development (IDB.5/29). The debate on the subject is reflected in summary record IDB.5/SR.11, paragraphs 27-58. The Board considered two draft decisions submitted by the President (IDB.5/L.33 and L.34) and adopted decisions IDB.5/Dec.19 and IDB.5/Dec.20 (see annex I). For statements made in connection with the adoption of decision IDB.5/Dec.20, see summary record IDB.5/SR.14, paragraphs 60-61.

VIII. REPORT OF THE PROGRAMME AND BUDGET COMMITTEE

26. The Board had before it the report of the Programme and Budget Committee on the work of its fifth session (IDB.5/13); a report by the

Director-General on applications of the splitcurrency system of assessment (IDB.5/8); an executive summary of the report on the mid-term evaluation of the Industrial Development Decade for Africa, prepared by the evaluation team (IDB.5/11), a note by the Secretariat on the Regional Co-operation Programme for the Industrial Recovery of Latin America and the Caribbean (IDB.5/CRP.12) and the documents mentioned in paragraphs 27 to 35 below. The Board decided to discuss simultaneously the report of the Programme and Budget Committee and its sub-items. The debate on the subject as a whole is reflected in summary records IDB.5/SR.6 - IDB.5/SR.8. In addition to the draft decisions mentioned in paragraphs 27-35 below, the Board also considered four draft decisions submitted by the President on a special programme for the industrial development of Asia and the Pacific (IDB.5/L.16 - PBC conclusion 1989/12), emergency industrial rehabilitation assistance (IDB.5/L.17 - PBC conclusion 1989/13), the establishment of a regional co-operation programme for the industrial recovery of Latin America and the Caribbean (IDB.5/L.18 - PBC conclusion 1989/16) and a special programme for industrial development in the Arab countries (IDB.5/L.19) and adopted decisions IDB.5/Dec.23, IDB.5/Dec.24, IDB.5/Dec.25 and IDB.5/Dec.26, respectively (see annex I). For a statement made in connection with the adoption of decision IDB.5/Dec.26, see summary record IDB.5/SR.14, paragraph 82.

A. Operational budget

27. The Board had before it PBC conclusion 1989/4 and a note by the Director-General on the status of the operational budget (IDB.5/CRP.8). The Board considered a draft decision on successor arrangements for agency support costs submitted by the President (IDB.5/L.34) which is reported on in chapter VII above.

B. Organizational and staff structure

28. The Board had before it PBC conclusion 1989/9; a report by the Director-General on the organizational and staff structure of UNIDO (IDB.5/7), the management review of the organizational and staff structure of UNIDO and the comments thereon by the Director-General (IDB.5/9 and Add.1 and Corr.1), a note by the Director-General on organizational and staff structure of UNIDO (IDB.5/33). The Board considered a draft decision submitted by the President (IDB.5/L.36). A roll-call vote was taken, at the request of the representative of Egypt. By 37 votes to 2, with 7 abstentions, the Board adopted decision IDB.5/Dec.21 (see annex I). For statements made in connection with the adoption of the decision, see summary record IDB.5/SR.14, paragraphs 66, 70 and 71.

C. Repayment of the United Nations loan

29. The Board had before it PBC conclusion 1989/10. The Board considered a draft decision submitted by the President (IDB.5/L.15) and adopted decision IDB.5/Dec.22 (see annex I).

D. Scale of assessments

30. The Board had before it PBC conclusions 1989/5 and 1989/6; a note by the Secretariat on scale of assessments for the fiscal years 1990 and 1991 (IDB.5/4); a note by the Secretariat on the status of assessed contributions paid and of advances to the Working Capital Fund (IDB.5/31) and an update

thereto (IDB.5/CRP.6). The Board considered two draft decisions submitted by the President (IDB.5/L.7 and L.9) and adopted decisions IDB.5/Dec.27 and IDB.5/Dec.28 respectively (see annex I). For statements made in connection with the adoption of decision IDB.5/Dec.28, see summary record IDB.5/SR.14, paragraphs 86, 88 and 89.

E. Financial performance report and programme performance report

31. The Board had before it PBC conclusion 1989/3 and an explanatory note by the Director-General on performance targets and programme outputs for the biennium 1988-1989 (IDB.5/38). The Board considered a draft decision submitted by the President (IDB.5/L.10) and adopted decision IDB.5/Dec.29 (see annex I).

F. Programme and budgets, 1990-1991

32. The Board had before it PBC conclusion 1989/11; proposals of the Director-General for the programme and budgets, 1990-1991 (IDB.5/5 and Corr.1); and proposed revisions (IDB.5/5/Add.1, IDB.5/CRP.11 and Corr.1). The Board considered a draft decision submitted by the President (IDB.5/L.8) and adopted decision IDB.5/Dec.30 (see annex I). For statements made in connection with the adoption of the decision, see summary record IDB.5/SR.14, paragraphs 94-99.

G. Working Capital Fund

33. The Board had before it PBC conclusion 1989/7; proposals by the Director-General for the Working Capital Fund for the biennium 1990-1991 (IDB.5/2); a status report of assessed contributions paid and advances to the Working Capital Fund (IDB.5/31, annex II) and an update thereto (IDB.5/CRP.6). The Board considered a draft decision submitted by the President (IDB.5/L.11) and adopted decision IDB.5/Dec.31 (see annex I).

H. Financial regulations

34. The Board had before it PBC conclusion 1989/14; and a report by the Director-General on applications of the split-currency system of assessment (IDB.5/8). The Board considered a draft decision submitted by the President (IDB.5/L.12) and adopted decision IDB.5/Dec.32 (see annex I).

I. Appointment of external auditors

35. The Board had before it PBC conclusion 1989/15. The Board considered a draft decision submitted by the President (IDB.5/L.13) and adopted decision IDB.5/Dec.33 (see annex I).

IX. INDUSTRIAL DEVELOPMENT FUND AND VOLUNTARY CONTRIBUTIONS

36. The Board had before it PBC conclusion 1989/8, and notes by the Director-General on the nature of projects financed from the Fund (IDB.5/3) and on the estimated resource level and proposed programming for 1990-1991 (IDB.5/6). The debate on the subject is reflected in summary record IDB.5/SR.8, paragraphs 39-63. The Board considered a draft decision submitted by the President (IDB.5/L.24) and adopted decision IDB.5/Dec.34 (see annex I).

X. MEDIUM-TERM PLAN, 1990-1995

37. The Board had before it a background note by the Secretariat (IDB.5/39). The debate on the subject is reflected in summary record IDB.5/SR.8, paragraphs 64-79. The Board considered an oral proposal by the President and adopted decision IDB.5/Dec.35 (see annex I).

- (a) Recommended to the General Conference at its third session to approve a second Industrial Development Decade for Africa (1991-2000);
- (b) Also recommended to the General Conference at its third session to request the General Assembly of the United Nations to proclaim, during its

forty-fourth session, a second Industrial Development Decade for Africa (1991-2000) for the purpose of accelerating, through the programmes and activities of other relevant United Nations organs and agencies, the industrialization of Africa that was initiated during the first Decade;

- (c) Further recommended that the General Conference at its third session take all the necessary measures for the formulation and implementation of a programme for a second IDDA;
- (d) Endorsed the allocation, in the proposed programme and budgets for the biennium 1990-1991, of a sum of \$8.6 million for the Special Programme for Africa and recommended to the General Conference to earmark this sum for the proposed second IDDA;
- (e) Requested the Director-General of UNIDO, in co-operation with the Executive Secretary of the Economic Commmission for Africa and the Secretary-General of the Organization of African Unity, and also the international organizations and the African regional and subregional organizations concerned, to provide the necessary assistance to the African countries for the preparation and implementation of their programmes and activities for the proposed second IDDA, including the organization of two meetings of the working group of governmental experts and of subregional meeting for this purpose;
- (f) Further requested the Director-General to strengthen and rationalize, within the UNIDO Secretariat, the mechanism for the co-ordination, monitoring and evaluation of the implementation of a programme for a second IDDA, with a view to remedying some of the shortcomings of the first IDDA pointed out in the mid-term evaluation report.

 - (iv) The additional payments shall be made in the month following the month in which they become due;
- (c) Took note of the agreement that UNIDO would provide an annual financial report to the Advisory Committee for Administrative and Budgetary Questions (ACABQ), at its fall session, so that ACABQ might review and submit recommendations on the question of accelerating UNIDO's loan repayment schedule;
 - (d) Requested the Director-General to retain:
 - (i) The unutilized balance, if any, in the 1988-1989 appropriations for use as a first charge on payment of the United Nations loan in 1990; and
 - (ii) The unutilized balance, if any, in the 1988-1989 outstanding obligations remaining at 31 December 1989 for payment of the United Nations loan in 1991.

IDB.5/Dec.23 SPECIAL PROGRAMME FOR THE INDUSTRIAL DEVELOPMENT OF ASIA AND THE PACIFIC

- (a) Noted the fact that over half the population of the Member States of UNIDO reside in Asia and the Pacific, and that as many as 13 least developed countries form part of the region;
- (b) Observed with concern the conditions of acute poverty afflicting many countries of the region due to lack of, and uneven, industrial growth;
- (c) Decided to establish a special programme for Asia and the Pacific, with its respective regional and subregional projects, geared to a rapid industrial growth of the developing countries of the region with special emphasis on the least developed countries, taking fully into account available natural and manpower resources based on the strengthening of existing programmes in UNIDO. - (d) Proposed the establishment of a special account within the Industrial Development Fund (IDF) for the above purpose and for the financing of technical co-operation projects and programmes for the industrial development of the least developed countries of the region;

- (e) Also decided to set up a suitable mechanism from available resources within the regular budget for the development and monitoring of the special programme for the industrial development of Asia and the Pacific;
- (f) Requested the Director-General, in implementing the programme of work contained in the regular budget for 1990-1991, to take into account the preparatory phase of this special programme;
- (g) Urged Member States to support the programme through voluntary contributions within the IDF, trust funds and other sources of funds.

IDB.5/Dec.24 EMERGENCY INDUSTRIAL REHABILITATION ASSISTANCE

- (c) Decided to establish a regional co-operation programme for the industrial recovery of Latin America and the Caribbean, with its respective regional and subregional components, based on the strengthening of existing programmes of UNIDO and on additional priority programmes to be agreed upon between Member States of the region and the Organization, covering inter alia the following areas:

- Biotechnology;
- Capital goods;
- Electronics;
- New materials;Data processing;
- Human resources;

The preparatory phase of the Regional Co-operation Programme for Latin America and the Caribbean would be financed out of available regular budget resources to initiate operational activities to be supported by financial resources from the Industrial Development Fund, trust funds and other sources of funds:

- (d) Further urged the Director-General to set up a suitable administrative mechanism from available resources, mainly from the regular budget, in order to develop an operational regional programme as described above and to facilitate the active participation of the countries in the region;
- (e) Requested the Secretariat to immediately begin the groundwork for the Regional Co-operation Programme for Latin America and the Caribbean, including the approval of the necessary preparatory assistance activities, and to submit to the General Conference at its third session a progress report on the implementation of this Programme.

- (iii) That the Special Programme would be financed out of available resources to initiate operational activities supported by financial resources from the Industrial Development Fund, trust funds and other sources of funds;
 - (iv) That the establishment of priorities for the Special Programme should be undertaken in consultation with the Arab countries and the Arab Industrial Development Organization;
- (b) Urged the Member States of UNIDO and the international institutions concerned with industrial development to support the Special Programme;
- (c) Requested the Director-General to submit a report on the implementation of the Special Programme to the Board at its sixth regular session.

Financial Regulation 4.2 (c)

"At the end of the twelve-month period referred to in sub-paragraph (b) above, the then remaining balance of any regular budget appropriations retained shall be reported in detail by the Director-General to the External Auditor for examination and review and, after deducting therefrom any contributions from Members relating to the fiscal period of the appropriations which remain unpaid, shall be surrendered to the Members in proportion to their assessed contributions at the end of the second calendar year following the fiscal period to which the appropriations relate, provided, however, that(etc.)."

DRAFT CONTRACT FOR APPOINTMENT OF THE DIRECTOR-GENERAL

THIS CONTRACT is made

between the United Nations Industrial Development Organization (hereinafter called the Organization) for the one part

and Mr. Domingo L. Siazon, Jr. (hereinafter called the Director-General) for the other part.

WHEREAS

The Director-General, upon recommendation of the Board, has been duly appointed by the Conference at its plenary meeting of its third regular session held on 1989 (GC.3/Dec.).

IT IS HEREBY AGREED AS FOLLOWS:

1. Term of Office

The Director-General shall be appointed for a period of four years from the first day of December nineteen hundred eighty-nine (1989), or until the Director-General appointed at the fifth regular session of the General Conference assumes office, whichever is later.

2. Official Duty Station

The official duty station for the Director-General shall be Vienna, Austria.

3. Official Duties

In accordance with Article 11 of the Constitution of the Organization, the Director-General shall be the chief administrative officer of the Organization.

4. Privileges and Immunities

The Director-General shall enjoy all the privileges and immunities in keeping with his office as determined by the Constitution of the Organization, Article 21, and any relevant legal instruments already in force or to be concluded in the future.

5. Staff Regulations

The Director-General shall be subject to the Staff Regulations of the Organization, together with such amendments as may be made thereto, in so far as they are applicable to him.

6. Assessable Salary and Allowances

- (a) The Director-General shall receive an annual gross salary of US dollars one hundred and fifty-nine thousand one hundred and fifteen (159,115) corresponding to an annual net base salary equivalent to US dollars seventy-eight thousand four hundred and thirty (78,430) (dependency rate) or US dollars sixty-nine thousand three hundred and thirty-four (69,334) (single rate) respectively;
- (b) He shall receive post adjustment, allowances and benefits, including social security benefits, for which a staff member in the Professional category of the UNIDO Secretariat would be eligible under the Staff Regulations and Staff Rules of the Organization, provided the purpose of such emolument, allowance or benefit has not already been met by other provisions of the present contract;
- (c) The Director-General shall receive a representation allowance of Austrian schillings two hundred sixty-five thousand (265,500) per annum, adjusted for the budgeted annual inflation rate, to meet his share of the obligations which the Organization incurs in the form of representation and hospitality expenditure;
- (d) He shall receive a housing allowance amounting to Austrian schillings four hundred seven thousand one hundred (407,100) per annum, adjusted for the budgeted annual inflation rate:

(e) The above assessable salary, allowances and benefits to which the Director-General is entitled under this agreement shall be subject to adjustment by the Board, after consultations with the Director-General, to keep them in line with those of the executive heads of other specialized agencies within the common system of the United Nations or of members of the staff of UNIDO in the Professional category, as the case may be.

7. Notice of Resignation

The Director-General may at any time give six months' notice of resignation in writing to the Board, which is authorized to accept his resignation on behalf of the General Conference, in which case, upon expiration of such period of notice, he shall cease to be Director-General of the Organization and this contract shall terminate.

8. Entry into force

This contract shall enter into force with retroactive effect to the first day of December 1989.

RECOMMENDATIONS FOR THE CONDUCT OF BUSINESS AND RATIONALIZATION OF PROCEEDINGS OF THE INDUSTRIAL DEVELOPMENT BOARD

Item 1: Number and duration of sessions of the Board per year

- 1. The financial resources and the number of working days (30 for the biennium including sessions of the Programme and Budget Committee) set aside in the programme budget are sufficient and should not be increased.
- 2. There should be two regular IDB sessions in non-General Conference years. In General Conference years a single regular session should suffice, but with a special brief session (preferably half a day) immediately following the General Conference.

Item 2: Agenda items for the Board

- 3. The agenda should be short and concise and should be prepared in compliance with the relevant statutory provisions.
- 4. Provisional agendas should be drawn up in biennial groups by the first session of the IDB following the General Conference. The Rules of Procedure allow the flexibility to add extra unforeseen items before each session. Certain items should be discussed only every second year, particularly those of a general nature. Other items should be assigned to the General Conference.
- 5. In the case of more than one regular session of the IDB per year, one session during a year should include an item dealing with UNIDO's policies, which should offer an opportunity for an exchange of ideas on substantive aspects of industrialization of developing countries.
- 6. Priority should be given to specific substantive items concentrating on the Annual Report, including separate discussion of its various subjects, and the opening statement of the Director-General. The grouping of a number of subjects under one agenda item should be avoided.

Item 3: Pre-session documentation

7. All documents (including the Annual Report) should be concise, clear, and submitted well in advance of each session in all of the official languages of UNIDO in accordance with the Rules of Procedure.

- 8. The practice of preparing more than one document on the same item should be avoided. Duplication and repetition should not occur.
- 9. Documents should address substantive matters. The Annual Report, being the most important document of the Organization, should be given more attention. A succinct update of the Annual Report should be issued only on those subjects for which the Board has requested a progress report or for which significant developments have taken place between the issuance of the Annual Report and the meeting of the Board.
- 10. Documents should clearly state at the end whether a Board decision is necessary.
- 11. Those documents dealing with programme activities should contain a brief description of the relevant budget appropriation, including general resources, inputs and outputs.
- 12. Reports of working groups should comply with rules 64 and 68.2 of the Rules of Procedure.

item 4: Procedure for preparation and discussion of draft decisions at sessions of the Board

A. PLENARY DEBATE

- 13. Dialogue and debate rather than repetitive ritualistic statements should be encouraged in the plenary. Except with the special consent of the Board no speech should exceed 15 minutes. Statements of congratulation to the President and members of the Bureau should be delivered only by the outgoing President.
- 14. Items that require no decision and on which no progress has been made should be covered by the Director-General's introductory remarks.
- 15. The Secretariat should give precise answers, as soon as possible and during the session, to questions relating to agenda items posed by Member States. The Secretariat should ensure that the relevant officials are present.

B. PRE-DECISION MAKING

- ...6. The President should organize informal consultations with Member States before sessions to identify items on which consensus could be reached and items on which there could be differing opinions.
- C. PREPARATION AND FACILITATION OF DECISION-MAKING
- 17. The plenary should be revitalized as the ${\tt decision-making\ body.}$
- 18. Member States which wish to submit draft decisions should do so in writing and well in advance, preferably after informal consultations with the President and other Member States.
- 19. When appropriate, after debate of each agenda item in the plenary the President should deliver a summary reflecting the main ideas and noting consensus where it exists.
- 20. Only where necessary the President with the consent of the Board should refer an agenda item to a working group to facilitate a consensus. Such groups should in this way be set up to assist and complement the plenary and should not duplicate or contradict it.

Item 5: Establishment of inter-sessional working groups

21. Only such inter-sessional working groups as are indispensable because of the importance of the items to be discussed or because of their implications on the work of the Organization should be established, the appropriate financial implications having been considered and approved.

Item 6: Participation of non-members and observers in the work of the Board

22. Participation of non-members and observers is adequately provided for in the Constitution and the Industrial Development Board Rules of Procedure.

Item 7: Reports of Board sessions

23. There were divergent views concerning the contents and format of the reports of the Board, and it was agreed that the matter would be kept under review.
