Introduction

1. The report of the Industrial Development Board on its sixth session is presented to the General Conference in accordance with Article 9.4 (c) of the Constitution. The summary records of the Board (IDB.6/SR.1-8), where details of the proceedings are contained, form an integral part of the present report.

3. The sixth session of the Board was held at UNIDO Headquarters, Vienna International Centre, from 28 May to 1 June 1990 (8 plenary meetings - see IDB.6/SR.1-8).

I. ORGANIZATIONAL AND PROCEDURAL MATTERS

Participation

4. Uganda, Ukrainian Soviet Socialist Republic, Union of Soviet Socialist Republics, United Kingdom of Great Britain and Northern Ireland, United States of America, Yugoslavia, Zaire.

5. The following non-governmental organizations were represented: International Association of Crafts and Small and Medium-sized Enterprises, International Confederation of Free Trade Unions, International Federation of Automatic Control, International Federation of Business and Professional Women, International Organization of Consumers Unions, International Organization of Experts, Society of Chemical Industry, Women's International Democratic Federation, World Assembly of Small and Medium Enterprises.

15. The Board adopted a proposal by the President to improve the utilization of available conference-servicing resources (see annex I, decision IDB.6/Dec.1).

16. The Board decided to set up informal in-session consultations with the aim of facilitating the drafting of decisions, and entrusted Vice-President V. Cserveny (Hungary) to chair those consultations (IDB.6/SR.2, paras. 1-2).

17. The debate on item 4 (UNIDO policies and the annual report of the Director-General for 1989 on the activities of the Organization) and its sub-items (a) to (k) (see sections A-L below) is reflected in the summary records IDB.6/SR.1 to IDB.6/SR.4 and IDB.6/SR.5, paragraphs 1 to 57.

A. UNIDO policies and the annual report of the Director-General for 1989 on the activities of the Organization

18. The Board had before it the Annual Report of UNIDO, 1989 (IDB.6/10) and an addendum to the Report containing an update for the period January to March 1990 (IDB.6/10/Add.1). On the proposal of the President the Board took note of the Annual Report of UNIDO, 1989 (IDB.6/10) and in particular chapter I on policy issues, as well as the update of the Annual Report for the period January to March 1990 (IDB.6/10/Add.1) (see IDB.6/SR.8, paras. 1-2).

B. Special regional programmes

(i) Special Programme for Industrial Development in the Arab Countries

19. The Board had before it a progress report by the Director-General on the Special Programme for Industrial Development in the Arab Countries (IDB.6/7 and Corr.1). The Board considered a draft decision submitted by the President (IDB.6/L.8) and adopted decision IDB.6/Dec.2 (see annex I).

(ii) Special Programme for the Industrial Development of Asia and the Pacific

20. The Board had before it a progress report by the Director-General on the Special Programme for the Industrial Development of Asia and the Pacific (IDB.6/8). The Board considered a draft decision submitted by the President. (IDB.6/L.1) and adopted decision IDB.6/Dec.3 (see annex I).

(iii) Regional Co-operation Programme for the Industrial Recovery of Latin America and the Caribbean

21. The Board had before it a progress report by the Director-General on the Regional Co-operation Programme for the Industrial Recovery of Latin America and the Caribbean (IDB.6/11). The Board considered a draft decision submitted by the President (IDB.6/L.2) and adopted decision IDB.6/Dec.4 (see annex I).

23. The Board had before it the Annual Report of UNIDO, 1989 (IDB.6/10, chap. III, paras. 1-16), a report by the Director-General on Consultations held in 1989 and plan for technical co-operation follow-up activities (IDB.6/12), proposals by the Director-General on a programme of Consultations for the biennium 1992-1993 (IDB.6/6), the report on the Consultation on the Food-processing Industry with Emphasis on Fruit and Vegetable Processing (ID/366), the report on the First Consultation on the Electronics Industry (ID/367), the report on the First Consultation on Small- and Medium-scale Enterprises including Co-operatives (ID/368) and the report on the Third Consultation on the Capital Goods Industry with Emphasis on Rural Transport Equipment (ID/370). The Board considered a draft decision submitted by the President (IDB.6/L.16) and adopted decision IDB.6/Dec.5 (see annex I).

E. Least developed countries

24. The Board had before it the Annual Report of UNIDO, 1989 (IDB.6/10, chap. IV, paras. 9-14) and an addendum to the Report containing an update for the period January to March 1990 (IDB.6/10/Add.1, paras. 4-11). The Board considered a draft decision submitted by the President (IDB.6/L.3) and adopted decision IDB.6/Dec.6 (see annex I).

F. Environment activities

25. The Board had before it the Annual Report of UNIDO, 1989 (IDB.6/10, chap. II, paras. 179-185) and a UNIDO environment programme proposed by the Director-General (IDB.6/3). The Board considered a draft decision submitted by the President (IDB.6/L.12) and adopted decision IDB.6/Dec.7 (see annex I).

G. Integration of women in industrial development

26. The Board had before it the Annual Report of UNIDO, 1989 (IDB.6/10, chap. IV, paras. 25-31) and an addendum to the Report containing an update for the period January to March 1990 (IDB.6/10/Add.1, paras. 26-29). The Board considered a draft decision submitted by the President (IDB.6/L.11) and adopted decision IDB.6/Dec.8 (see annex I).

H. UNIDO technical co-operation activities in 1989

27. The Board had before it the Annual Report of UNIDO, 1989 (IDB.6/10), a note by the Secretariat on UNIDO technical co-operation activities in 1989 (IDB.6/18) and a list of technical co-operation projects approved and/or operational in 1989 (IDB.6/CRP.1). The Board considered a draft decision submitted by the President (IDB.6/L.4) and adopted decision IDB.6/Dec.9 (see annex I).

I. Programmes and activities financed by special trust funds

28. The Board had before it the Annual Report of UNIDO, 1989 (IDB.6/10, chap. VIII, paras. 22-28), a report by the Director-General on programmes and

activities financed by special trust funds (IDB.6/16) and lists of ongoing or completed special trust fund projects, 1 January 1987 to 31 March 1990 (IDB.6/CRP.2). The Board considered a draft decision submitted by the President (IDB.6/L.15) and adopted decision IDB.6/Dec.10 (see annex I).

J. Economic co-operation among developing countries

29. The Board had before it the Annual Report of UNIDO, 1989 (IDB.6/10, chap. IV, paras. 15-24) and an addendum to the Report containing an update for the period January to March 1990 (IDB.6/10/Add.1, paras. 12-25). The Board considered a draft decision submitted by the President (IDB.6/L.7) and adopted decision IDB.6/Dec.11 (see annex I).

K. Technical assistance to Namibia

30. The Board had before it the Annual Report of UNIDO, 1989 (IDB.6/10, chap. II, para. 21) and an addendum to the Report containing an update for the period January to March 1990 (IDB.6/10/Add.1, para. 2). The Board considered a draft decision submitted by the President (IDB.6/L.5) and adopted decision IDB.6/Dec.12 (see annex I).

L. Technical assistance to the South African national liberation movements recognized by the Organization of African Unity

31. The Board had before it the Annual Report of UNIDO, 1989 (IDB.6/10, chap. II, para. 22) and an addendum to the Report containing an update for the period January to March 1990 (IDB.6/10/Add.1, para. 3). The Board considered a draft decision submitted by the President (IDB.6/L.6) and adopted decision IDB.6/Dec.13 (see annex I).

III. EVALUATION ACTIVITIES OF UNIDO

32. The Board had before it the Annual Report of UNIDO, 1989 (IDB.6/10, chap. V) and a report by the Director-General on evaluation activities of UNIDO (IDB.6/2). The debate on the subject is reflected in summary record IDB.6/SR.6, paragraphs 3 to 28. The Board considered a draft decision submitted by the President (IDB.6/L.9) and adopted decision IDB.6/Dec.14 (see annex I).

IV. INDUSTRIAL INVESTMENT PROMOTION

33. The Board had before it the Annual Report of UNIDO, 1989 (IDB.6/10, chap. III, paras. 37-47) and a progress report by the Director-General on industrial investment promotion activities of UNIDO (IDB.6/9). The debate on the subject is reflected in summary record IDB.6/SR.7, paragraphs 29 to 76. The Board considered a draft decision submitted by the President (IDB.6/L.13) and adopted decision IDB.6/Dec.15 (see annex I).

V. CONTRIBUTION OF UNIDO TO THE PREPARATION OF AN INTERNATIONAL DEVELOPMENT STRATEGY FOR THE FOURTH UNITED NATIONS DEVELOPMENT DECADE

34. The Board had before it a progress report by the Director-General on the contribution of UNIDO to the preparation of an international development strategy for the fourth United Nations development decade (IDB.6/5). The debate on the subject is reflected in summary record IDB.6/SR.7, paragraphs 1 to 25. The Board considered a draft

VI. ADMINISTRATIVE MATTERS (INCLUDING CO-ORDINATION AMONG VIENNA-BASED ORGANIZATIONS) AND HEADQUARTERS AGREEMENT BETWEEN UNIDO AND THE REPUBLIC OF AUSTRIA

35. The Board had before it a report by the President of the fifth session of the Industrial Development Board on co-ordination of the administrative activities of Vienna-based organizations within the United Nations system (IDB.6/20), a note by the Secretariat on issues related to the United Nations common system and the International Civil Service Commission (IDB.6/22), and reports by the Director-General on a Headquarters agreement between UNIDO and the Republic of Austria (IDB.6/17) and on space requirements at the Vienna International Centre (IDB.6/14). The debate on these subjects is reflected in summary record IDB.6/SR.7, paragraphs 77 to 95. The Board considered two draft decisions submitted by the President (IDB.6/L.17 and L.20) and adopted decisions IDB.6/Dec.17 and IDB.6/Dec.18 (see annex I). For a statement made in connection with the adoption of decision IDB.6/Dec.18, see summary record IDB.6/SR.8, paragraph 54.

VII. MATTERS RELATING TO INTERGOVERNMENTAL, NON-GOVERNMENTAL, GOVERNMENTAL AND OTHER ORGANIZATIONS

36. The Board had before it two notes by the Director-General containing information on intergovernmental organizations not in the United Nations system (IDB.6/15 and Add.1) and on applications from non-governmental organizations for consultative status (IDB.6/4). The debate on the subject is reflected in summary record IDB.6/SR.6, paragraphs 1 and 2, and IDB.6/SR.7, paragraphs 96 to 99. The Board considered recommendations of the Bureau that were submitted orally by the President and adopted decisions IDB.6/Dec.19 and IDB.6/Dec.20 (see annex I).

VIII. OPERATIONAL ACTIVITIES FOR DEVELOPMENT

37. The Board had before it United Nations General Assembly resolution 44/211 on the comprehensive triennial policy review of operational activities for development of the United Nations system and a note by the Director-General on the implementation of General Assembly resolution 44/211 (IDB.6/19). The debate on the subject is reflected in summary record IDB.6/SR.7, paragraphs 26 to 28. The Board

had before it a draft decision submitted by the President (IDB.6/L.19) and adopted decision IDB.6/Dec.21 (see annex I).

IX. AGENCY SUPPORT COSTS

38. The Board had before it a report by the Director-General on successor arrangements for agency support costs (IDB.6/21-PBC.6/14). The debate on the subject is reflected in summary records IDB.6/SR.1-4; IDB.6/SR.5, paragraphs 1-57; IDB.6/SR.6, paragraphs 29-105. After extensive consultations with a number of delegations the President proposed, as a compromise, the text of a draft letter to be sent by him to the President of the Governing Council of the United Nations Development Programme (UNDP) reflecting the discussions on the subject and enclosing the relevant summary records. In the context of that issue, the Board considered a procedural draft decision proposed orally by the President authorizing him to forward the letter to the President of the UNDP Governing Council. The Board, with a minor amendment to the letter (IDB.6/SR.8, paras. 67-68), adopted decision IDB.6/Dec.22 (see annex I). For a statement made in connection with the adoption of the decision, see summary record IDB.6/SR.8, paragraph 71.

X. EVALUATION OF THE OBJECTIVES AND FUNCTIONS OF UNIDO IN VIEW OF RECENT CHANGES AND DEVELOPMENTS IN THE WORLD

39. The Board had before it a statement by the Group of 77 contained in document IDB.6/1/Rev.2/Add.1/Corr.1. The debate on the subject is reflected in summary records IDB.6/SR.1 to IDB.6/SR.5. The Board considered a draft decision submitted by the President (IDB.6/L.14) and adopted decision IDB.6/Dec.23 (see annex I).

XI. PROVISIONAL AGENDA FOR THE SEVENTH SESSION

40. The Board considered a list of items for the provisional agenda of its seventh session contained in Board decision IDB.6/S.3/Dec.2, and adopted decision IDB.6/Dec.24 (see annex I).

XII. ADOPTION OF THE REPORT AND CLOSURE OF THE SIXTH SESSION

41. The Board considered the draft report (IDB.6/L.10) and adopted the report as a whole, on the understanding that the Rapporteur would be entrusted with the task of finalizing the report (see IDB.6/SR.8, paras. 77-79).

42. On 1 June 1990, the Board closed its sixth session.

Regional Conference on New Industrialization Policies to be held at Sao Paulo (Brazil) from 27 to 30 November 1990;

- (i) To initiate the implementation of and to seek financing for the five already identified projects of the Regional Programme and submit to the States of the region for their consideration additional projects in priority areas already identified. Those additional projects ought to form a set that, in terms of the quality and number of its component elements, would lead to a broad-based and comprehensive Regional Programme;
- (ii) To inform, on an ongoing basis, the Governments of the region through their Permanent Missions regarding the progress of each of the projects during the stages of project formulation, the search for financing and project implementation in order that the States of the region might suggest such adjustments as they deem necessary;
- (iii) To take into account the recommendations of the 1990 Regional Conference on New Industrialization Policies to be organized by SELA and, in the same way, to consider the guidelines that may be drawn up by both SELA and the Economic Commission for Latin America and the Caribbean, as well as those suggested by the UNIDO Country Directors and the Regional Adviser, for the smooth operation of the Regional Programme;
- (iv) In accordance with resolution GC.3/Res.17, to submit a full and detailed report on the Regional Programme, in which the biennial programming activities by project, identification of the existing and potential financing sources and the allocation of resources obtained are clearly specified in order to review and widen the portfolio of projects;
- (v) To assign, for the implementation of the Regional Programme, an appropriate number of full-time professionals and administrative support personnel to the co-ordination machinery, without involving any additional expense to the Organization;
- (vi) To allocate additional resources through redeployment, as far as circumstances allow, for the execution of the Regional Programme, taking into account the limited amounts that had been made available to it up to the time of the adoption of the present decision;

- (vii) To take the necessary administrative and budgetary steps, within available resources, so that the representatives of the national counterpart agencies might participate in the regional meetings to review the Regional Programme during the period 1990 to 1991;

(e) Also requested the Director-General to submit a full and detailed report on the execution of each of the measures requested in the present decision, through the Board at its eighth session, to the General Conference at its fourth session.

(iii) To continue close co-operation with other United Nations agencies on the United Nations System-wide Medium-term Environment Programme 1990-1995 and conclude a working arrangement between UNIDO and the United Nations Environment Programme (UNEP);

(iv) To ensure that a broad dialogue between Member States and the Secretariat determine the guidelines for UNIDO participation and contributions to the United Nations Conference on

Environment and Development, participation which should be in full compliance with General Assembly resolution 44/228;

- (v) To present to the Preparatory Committee for the United Nations Conference on Environment and Development at its meeting in August 1990, an outline for UNIDO's contribution to the Conference;

LETTER OF THE PRESIDENT OF THE BOARD TO THE
PRESIDENT OF THE GOVERNING COUNCIL OF THE
UNITED NATIONS DEVELOPMENT PROGRAMME
ON ITEM 11: AGENCY SUPPORT COSTS

"The Industrial Development Board, during
its sixth session, having considered document
IDB.6/21, had intensive discussions on the subject
of agency support costs. As President of the
Industrial Development Board, I hereby wish to
convey the essence of the discussions, as
follows:

'The Industrial Development Board took
note of the options proposed in the report of
the expert group on the study of successor
arrangements for support costs and related
issues, as well as other proposals put forward
by the Administrator of UNDP, CCAQ(FB),
specialized agencies and in particular by
UNIDO, and more recently by the President of
the UNDP Governing Council.

'The Industrial Development Board assumed
that at the thirty-seventh session of the
Governing Council of UNDP, a framework decision
will be taken, outlining the general structure
for the successor arrangements to facilitate
consultations between UNDP and agencies. It
recommended that after such consultations,
detailed decisions on successor arrangements be
made with as full analysis as is possible of the
financial impact on the organizations of the
United Nations system and its implications for
agency budgets, particularly stemming from cost
sharing.

'The Board believed that the present
discussion and debate offered a timely oppor-
tunity to redefine the tripartite relationship.
At the same time, it reaffirmed the importance
of maintaining the technical expertise of
specialized agencies and considered that its
availability to developing countries should be
ensured.

'Desiring to strengthen further the
capacities of developing countries, the Board
reaffirmed the view that there should be gradual
implementation of government/national execution
of projects in accordance with national
capabilities and government priorities, and
that transitional arrangements, whenever
appropriate, should be adopted to enable
Governments and agencies to adjust to any
new system of support costs and to changing
functions envisaged for Governments and
agencies.

'The Board further believed that it
is most important that any new arrangements
should promote greater coherence, effectiveness
and transparency in United Nations technical
co-operation activities within the framework of
a programme approach and thereby best meet the
need of developing countries.'

"The Board requested me to inform you of its
views. For further information I would like to
refer you to the summary records of the Industrial
Development Board on this issue."

IDB.6/Dec.23 EVALUATION OF THE OBJECTIVES
AND FUNCTIONS OF UNIDO IN
VIEW OF RECENT CHANGES AND
DEVELOPMENTS IN THE WORLD

The Industrial Development Board:

(a) Recalled the final declaration of the eighteenth special session of the General Assembly on international co-operation;

(b) Reaffirmed the objectives and functions of UNIDO as stated in Articles 1 and 2 of the Constitution;

(c) Reaffirmed that the industrialization of the developing countries, considered as a process in which investment, production and employment in industry develop simultaneously, constitutes a fundamental activity in the promotion of those countries' economic and social progress;

(d) Reaffirmed further that industrialization calls for greater and more sustained commitment by the international community, in particular through strengthening of UNIDO's role in accelerating industrial development in developing countries;

(e) Noted that despite the achievements of UNIDO, the aims and goals set for the developing countries in the Lima Declaration and Plan of Action on Industrial Development and Co-operation (ID/CONF.3/31, chap. IV) had not been fully realized, *inter alia*, due to lack of sufficient resources;

(f) Further noted that, as a consequence of the recent developments in east-European countries, there had been an increasing demand for technical co-operation from UNIDO for the modernization of the economies and enterprises of those countries;

(g) Stressed that in responding to the new challenges, the primary objectives of UNIDO must be maintained and its operational activities to assist developing countries should not be reduced;

(h) Expressed its concern at the insufficiency of the resources available for UNIDO's operational activities in relation to the needs of the developing countries;

(i) Requested the Director-General to ensure that the voluntary contributions he accepts on behalf of UNIDO are consistent with the objectives and policies of the Organization and to prepare an updated and consolidated framework of regulations for the implementation of Article 16 of the Constitution for submission to the Board at its eighth session, as also requested in decision IDB.6/Dec.10 on special trust funds;

(j) Further requested the Director-General to ensure that the technical co-operation demands derived from the recent developments mentioned in paragraph (f) above do not detract from available resources for the industrial development of the developing countries;

(k) Stressed the primary importance of financing UNIDO's development activities, and recognized the value of resources in the form of special-purpose contributions, inasmuch as they

serve to procure supplementary injections of resources for implementing projects in developing countries, provided they are coherently and effectively integrated into the technical co-operation programmes of UNIDO;

(l) Urged Member States to comply with their commitments in terms of the objectives and functions of UNIDO and urged all countries, especially developed ones, to make substantial increases in the real value of resources they earmark for operational development activities, in particular in the industrial field;

(m) Also requested the Director-General to ensure that UNIDO, in accordance with its primary objectives, promote the active participation of developing countries in the current process of readjustment of the world economy;

(n) Further requested the Director-General to submit a report on the implementation of the present decision, through the Board at its eighth session, to the General Conference at its fourth session.
