Introduction

- 1. The report of the Industrial Development Board on the work of its tenth session is presented to the General Conference in accordance with Article 9.4 (c) of the Constitution. The summary records of the Board (IDB.10/SR.1-8), where details of the proceedings are contained, form an integral part of the present report.
- 2. The following decisions of the Board, reproduced in annex I, are of relevance to the tentative provisional agenda and background information for the fifth session of the Conference:

- 3. The tenth session of the Board was held at UNIDO Headquarters, Vienna International Centre, from 2 to 6 November 1992 (eight plenary meetings see IDB.10/SR.1-8).
 - I. ORGANIZATIONAL AND PROCEDURAL MATTERS

<u>Participation</u>

- 4. The following 52 of the 53 members of the Board were represented at the session: Austria, Belarus, Belgium, Bolivia, Brazil, Cameroon, Chile, China, Costa Rica, Cuba, Czechoslovakia, Egypt, Ethiopia, Finland, France, Germany, Greece, Guinea, Hungary, India, Indonesia, Iran (Islamic Republic of), Iraq, Italy, Japan, Kuwait, Mexico, Morocco, Netherlands, Nigeria, Norway, Pakistan, Peru, Republic of Korea, Romania, Russian Federation, Saudi Arabia, Senegal, Spain, Sudan, Switzerland, Syrian Arab Republic, Thailand, Trinidad and Tobago, Tunisia, Turkey, Uganda, United Kingdom of Great Britain and Northern Ireland, United States of America, Venezuela, Zaire, Zimbabwe.
- 5. 12. Owing to the departure of V. Cserveny (Hungary), President of the ninth session of the Industrial Development Board, the tenth session of the Board was declared open by the Acting President, T. M. Machado Quintella (Brazil).

Election of the President

13. In accordance with paragraph 2 of rule 24 of the rules of procedure, the Board elected by acclamation P. BALAZS (Hungary) as President of the tenth session.

Organization of work

16. The Board adopted a proposal by the President to improve the utilization of available conference-servicing resources (see annex I, decision IDB.10/Dec.1).

- 17. The Board decided to set up informal, open-ended consultations under the chairmanship of the President of the Board, P. Balázs (Hungary), with the aim of reaching a consensus on agenda item 16, Actions to be taken by the Industrial Development Board following the resignation of the Director-General (IDB.10/SR.1, paras. 26-27 and IDB.10/SR.2, paras. 1-10).
- 18. The Board also decided to set up informal in-session consultations with the aim of facilitating the drafting of decisions on items 3 to 10 and 12 to 14, and entrusted Vice-President T. M. Machado Quintella (Brazil) to chair those consultations (IDB.10/SR.2, paras. 12-13).

PROGRESS REPORT FOR 1992 ON SPECIFIC UNIDO ACTIVITIES

19. The Board had before it a progress report for 1992 on specific UNIDO activities (IDB.10/18 and Add.1). The debate on the subject is reflected in summary records IDB.10/SR.4, paragraphs 38-91. The Board considered a draft decision submitted by the President (IDB.10/L.1) and, with two amendments, adopted decision IDB.10/Dec.2. The Board considered a second draft decision submitted by the President (IDB.10/L.3) and adopted decision IDB.10/Dec.3 (see annex I).

III. REPORT OF THE PROGRAMME AND BUDGET COMMITTEE

The Board decided to discuss simultaneously sub-items 4 (a) to (1) of the agenda. The Board had before it the report of the Programme and Budget Committee (PBC) on the work of its eighth session (IDB.10/14) and the documents mentioned in sections A to L below. The debate on item 4 as a whole is reflected in summary records IDB.10/SR.1, paragraphs 33 to 54, IDB.10/SR.2, paragraphs 14 to 72 and IDB.10/SR.3, paragraphs 1 to 20.

Report of the External Auditor, financial performance report and programme performance report for the biennium 1990-1991

21. The Board had before it the financial performance report for the biennium 1990-1991 submitted by the Director-General (IDB.10/3), the report of the External Auditor on the accounts of UNIDO and of the Industrial Development Fund for the financial period 1990-1991 (IDB.10/4), the Annual Report of UNIDO, 1991 (IDB.9/10 and Corr.1 and Corr.2) reflecting the programme performance report for the biennium 1990-1991, the comments of the Director-General on the report of the External Auditor (IDB.10/11), a report by the Director-General on net basis budgeting (IDB.10/11/Add.1), and a report by the Director-General on implementation of the recommendations of the External Auditor for the financial period 1990-1991 (IDB.10/25). The Board considered a draft decision submitted by the President (IDB.10/L.15) and adopted decision IDB.10/Dec.4 (see annex I).

B. Use of unutilized balances of appropriations

22. The Board took note that, in compliance with the request in General Conference decision GC.4/Dec.15, the External Auditor had submitted his opinion to the Programme and Budget Committee

on the allocation of any retained unutilized balances of the regular budget appropriations of UNIDO to those original programmes that had been affected, and that the Committee in its conclusion 92/3 had taken note of that report with appreciation (IDB.10/SR.8, paras. 14-15).

C. Implementation of the recommendations of the External Auditor for the financial period 1988-1989

23. The Board had before it two reports by the Director-General, one on action taken with regard to the manual on administrative policies and procedures of the Organization (IDB.10/6/Rev.1) and the other on economies in the official travel costs of the Organization (IDB.10/26). The Board took note of conclusion 92/4 of the Programme and Budget Committee (IDB.10/SR.8, paras. 16-17).

D. Financial situation of UNIDO

24. The Board had before it a report by the Director-General on the financial situation of UNIDO (IDB.10/27 and Corr.1) and a note by the Secretariat on losses related to small catering items (IDB.10/9). The Board considered two draft decisions submitted by the President (IDB.10/L.9 and IDB.10/L.18) and adopted decisions IDB.10/Dec.5 and IDB.10/Dec.6 (see annex I). For statements made in connection with the adoption of decision IDB.10/Dec.6, see summary record IDB.10/SR.8, paragraphs 21 to 29.

E. Application of the split-currency system of assessment

25. The Board had before it a report by the Secretariat on the application of the split-currency system of assessment (PBC.8/11). The Board, recalling General Conference resolution GC.4/Res.27, paragraph 8, took note of conclusion 92/7 of the Programme and Budget Committee on the appropriateness of the second sentence of financial regulation 5.1 (d) concerning the split-currency system of assessment (IDB.10/SR.8, paras. 30-31).

F. Operational budget: reimbursement for programme support and administrative services

26. The Board had before it a report by the Director-General on the cost measurement study on the United Nations Development Programme successor arrangements for agency support costs (IDB:10/7) and a proposal by the Director-General on reimbursement for special trust fund projects in accordance with financial rule 106.21 (IDB:10/8). The Board, recalling General Conference resolution GC.4/Res.28, took note of conclusion 92/8 of the Programme and Budget Committee concerning the application of financial rule 106.21 (IDB:10/SR.8, paras. 32-33).

G. Guidelines and procedures governing acceptance and funding under special trust funds. Industrial Development Fund and the regular budget

27. The Board considered a report by the Director-General on a regulatory framework for the implementation of Articles 16 and 17 of the Constitution (IDB.10/10).

H. Medium-term plan, 1994-1999 (including general ceiling for the biennium 1994-1995)

28. The Board had before it the draft medium-term plan, 1994-1999 (IDB.10/5) and a preview of the first biennium 1994-1995 and preliminary indicative general ceiling (IDB.10/5/Add.1) submitted by the Director-General, as well as a report by the Chairman of the Programme and Budget Committee on priorities within the medium-term plan, 1994-1999 (IDB.10/29). The Board considered two draft decisions submitted by the President (IDB.10/L.8 and IDB.10/L.21) and adopted decisions IDB.10/Dec.7 and IDB.10/Dec.8 (see annex I).

I. <u>Industrial Development Fund and other</u> voluntary contributions

29. The Board had before it a report by the Director-General on the estimated resource level and programming for 1993-1994 for the Industrial Development Fund (IDB.10/2) and information on the nature of projects financed from the Fund, contained in the Annual Report of UNIDO, 1991 (IDB.9/10, chap. VIII, paras. 14-20 and appendix G). The Board considered a draft decision submitted by the President (IDB.10/L.11) and adopted decision IDB.10/Dec.9 (see annex I).

J. Electronic data-processing programme

30. The Board considered a report by the Director-General on the electronic data-processing programme (IDB.10/30).

K. <u>Financial regulation 4.1</u>, <u>paragraphs (d) and (e)</u>

31. The Board considered a draft decision submitted by the President (IDB.10/L.16) and adopted decision IDB.10/Dec.10 (see annex I).

L. UNIDO Country Director programme

32. The Board had before it a report by the Director-General on the financial situation of the UNIDO Country Director programme (IDB.10/34 and Corr.1). The Board considered a draft decision submitted by the President (IDB.10/L.6) and adopted decision IDB.10/Dec.11 (see annex I).

IV. SPECIAL PROGRAMME FOR INDUSTRIAL DEVELOPMENT IN THE ARAB COUNTRIES

33. The Board had before it a progress report by the Director-General on the Special Programme for Industrial Development in the Arab Countries (IDB.10/12). The debate on the subject is reflected in summary record IDB.10/SR.6, paragraphs 30 to 47. The Board considered a draft decision submitted by the President (IDB.10/L.7) and adopted decision IDB.10/Dec.12 (see annex I).

V. UNIDO ENVIRONMENT PROGRAMME

34. The Board had before it an updated UNIDO environment programme submitted by the Director-General (IDB.10/17) and a report by the Director-General containing the response of

UNIDO to Agenda 21 (IDB.10/32). The debate on the subject is reflected in summary records IDB.10/SR.4, paragraphs 93 to 108, IDB.10/SR.5, paragraphs 3 to 34, and IDB.10/SR.6, paragraphs 1 to 29. The Board considered a draft decision submitted by the President (IDB.10/L.20) and adopted decision IDB.10/Dec.13 (see annex I).

VI. FINANCIAL RESOURCES FOR INDUSTRIAL DEVELOPMENT

35. The Board decided to discuss simultaneously items 7 (Guidelines for special trust fund projects), 8 (Mobilization of financial resources for industrial development) and 9 (The external debt and industrial development). The debate on the three subjects is reflected in summary records IDB.10/SR.3, paragraphs 21 to 94 and IDB.10/SR.4, paragraphs 1 to 12.

A. <u>Guidelines for special trust fund</u> projects

36. The Board had before it a report by the Director-General containing guidelines for special trust fund projects (IDB.10/15), a proposal by the Director-General for reimbursement for special trust fund projects in accordance with financial rule 106.21 (IDB.10/8) (see also chap. III, section F, above) and a report by the Director-General on a regulatory framework for the implemention of Articles 16 and 17 of the Constitution (IDB.10/10) (see also chap. III, section G, above). The Board considered a draft decision submitted by the President (IDB.10/L.5) and adopted decision IDB.10/Dec.14 (see annex I).

B. Mobilization of financial resources for industrial development

37. The Board had before it a progress report by the Director-General on mobilization of financial resources for industrial development (IDB.10/20). The Board considered a draft decision submitted by the President (IDB.10/L.2) and adopted decision IDB.10/Dec.15 (see annex I).

C. The external debt and industrial development

38. The Board had before it a progress report by the Director-General on the external debt and industrial development (IDB.10/20). The Board considered a draft decision submitted by the President (IDB.10/L.10) and adopted decision IDB.10/Dec.16 (see annex I). For a statement made in connection with the adoption of that decision, see summary record IDB.10/SR.8, paragraphs 55 to 59.

VII. EVALUATION OF THE OBJECTIVES AND FUNCTIONS OF UNIDO IN VIEW OF RECENT CHANGES AND DEVELOPMENTS IN THE WORLD

39. The Board had before it a report by the Director-General on the evaluation of the objectives and functions of UNIDO in view of recent changes and developments in the world (IDB.10/21). The debate on the subject is reflected in summary record IDB.10/SR.6, paragraphs 48 to 120.

VIII. ORGANIZATIONAL AND STAFF STRUCTURE OF UNIDO

40. The Board had before it a report by the Director-General on the organizational and staff structure of UNIDO (IDB.10/24). The debate on the subject is reflected in summary record IDB.10/SR.4, paragraphs 13 to 37. After a debate on procedures, the Board decided to adjourn the consideration of a decision on the subject to its eleventh session (IDB.10/SR.8, paras. 80-107). For statements made in connection with that decision, see summary record IDB.10/SR.8, paragraphs 108 to 116.

IX. HEADQUARTERS AGREEMENT BETWEEN UNIDO AND THE REPUBLIC OF AUSTRIA

41. The Board had before it a report by the Director-General on the Headquarters agreement between UNIDO and the Republic of Austria (IDB.10/23). The debate on the subject is reflected in summary record IDB.10/SR.7, paragraphs 15 to 16. At the suggestion of the President, the Board took note of the documentation and information provided by the Secretariat (IDB.10/SR.8, paras. 61-62).

X. ADMINISTRATIVE MATTERS

A. Joint Inspection Unit

42. The Board had before it a note by the Secretariat on activities of the Joint Inspection Unit in 1991 and early 1992 of relevance to UNIDO (IDB.10/22). The debate on the subject is reflected in summary record IDB.10/SR.7, paragraphs 17 to 20 and 25. At the suggestion of the President, the Board took note of the information provided by the Secretariat (IDB.10/SR.8, paras. 63-64).

B. <u>International Civil Service</u> <u>Commission</u>

43. The Board had before it a note by the Secretariat on issues related to the United Nations common system and pension system (IDB.10/28), a note by the Secretariat on action taken by the International Civil Service Commission under article 14 of its statute: status of women in the United Nations system (IDB.10/CRP.2). The Board also had before it a report by the Director-General on representation of the UNIDO governing body on the UNIDO Staff Pension Committee (IDB.10/33), a list of staff of the UNIDO Secretariat as at 30 September 1992 (IDB.10/CRP.1) and a statement of the staff of UNIDO submitted by the Staff Council through the Director-General (IDB.10/36). The debate on the subject is reflected in summary record IDB.10/SR.7, paragraphs 17, 21 to 23 and 25 to 29. The Board considered two draft decisions submitted by the President (IDB.10/L.13 and IDB.10/L.12) and adopted decisions IDB.10/Dec.17 and IDB.10/Dec.18 (see annex I).

XI. PREPARATORY ARRANGEMENTS FOR THE FIFTH SESSION OF THE GENERAL CONFERENCE

 $44. \ \ \,$ The Board had before it a progress report by the Director-General on the agreement with the

Government of Cameroon on the venue of the fifth session of the General Conference (IDB.10/31) and a note by the Secretariat on the preparation of the provisional agenda of the fifth session of the General Conference (IDB.10/19). The debate on the subject is reflected in summary record IDB.10/SR.7, paragraphs 1 to 14. The Board considered a draft decision submitted by the President (IDB.10/L.14) and, with an amendment, adopted decision IDB.10/Dec.19 (see annex I). At the suggestion of the President, the Board also took note of the information provided in document IDB.10/31 on the signing of the agreement between UNIDO and the Government of Cameroon concerning the venue of the fifth session of the General Conference (IDB.10/SR.8, paras. 78-79).

XII. MATTERS RELATED TO INTERGOVERNMENTAL, NON-GOVERNMENTAL, GOVERNMENTAL AND OTHER ORGANIZATIONS

45. The Board had before it notes by the Director-General on information on intergovernmental organizations not in the United Nations system (IDB.10/16 and Add.1) and on applications from non-governmental organizations for consultative status (IDB.10/13). The debate on the subject is reflected in summary record IDB.10/SR.7, paragraphs 30 to 43. The Board considered two draft decisions submitted orally by the President and adopted decisions IDB.10/Dec.20 and IDB.10/Dec.21 (see annex I).

XIII. ACTIONS TO BE TAKEN BY THE INDUSTRIAL DEVELOPMENT BOARD FOLLOWING THE RESIGNATION OF THE DIRECTOR—GENERAL

46. The Board had before it information provided in the annotated provisional agenda under item 16

(IDB.10/1/Rev.1/Add.1). The item was considered at informal open-ended consultations (see para. 17 above) on which a report was submitted drally by the President to the plenary (summmary record IDB.10/SR.5, paras. 1-2). The Board considered a draft decision submitted by the President with an oral amendment (IDB.10/L.4) and adopted decision IDB.10/Dec.22 (see annex I). For statements made in connection with the adoption of the decision, see summary record IDB.10/SR.8, paragraphs 70 and 72 to 75.

XIV. PROVISIONAL AGENDA AND DATE OF THE ELEVENTH SESSION

47. The Board considered a draft decision submitted by the President (IDB.10/L.19) and adopted decision IDB.10/Dec.23 (see annex I).

XV. ADOPTION OF THE REPORT OF THE TENTH SESSION

48. The Board considered the draft report (IDB.10/L.17) and adopted it as a whole with the understanding that the Rapporteur would be entrusted with the task of finalizing the report (see summary record IDB.10/SR.8, paras. 119-120).

XVI. SUSPENSION OF THE TENTH SESSION

49. On 6 November 1992, the Board, in accordance with its decision IDB.10/Dec.22, suspended its tenth session until 29 March 1993, when it will reconvene for one day only, for the sole purpose of recommending to the General Conference a candidate for the post of Director-General.

- (a) Recalled the Declaration on International Economic Cooperation adopted by the General Assembly at its eighteenth special session on 1 May 1990 (A/Res/S-18/3), General Assembly resolution 45/214 and the report of the Secretary-General on the issue of international debt (A/45/656);
- (b) Further recalled General Conference resolution GC.4/Res.22 on the external debt and industrial development, according to which the external debt problems of the developing debtor countries, particularly the least developed countries, should be given continued serious attention and an early broad and durable solution:
- (c) Took note of the report of the Director-General contained in document IDB.10/20;

- (d) Was cognizant of the correlation between external debt and industrialization and improved access to developed country markets of manufactures and semi-manufactures from developing countries:
- (e) Expressed its appreciation for the various initiatives of a number of developed countries to alleviate the official debts of groups of developing countries, bearing in mind the impact of external debt burdens on the industrial development of those countries, and the severe effects of the external debt servicing on their economies which represent serious obstacles to their industrial development;
- (f) Bore in mind the role of UNIDO as an instrument that could contribute to the alleviation of the negative effects of external debt of the developing countries;
- (g) Requested the Director-General to orient the activities of UNIDO to the mandate laid down in paragraph 1 (a) of General Conference resolution GC.2/Res.11, which is aimed, through industrial development, at alleviating the negative effects of external debt in the developing countries;
- (h) Further requested the Director-General to continue to implement Board decision IDB.7/Dec.20 and Conference resolution GC.4/Res.22, paragraphs 2 to 6, on the external debt and industrial development;

 - (i) To take into account existing debt burdens in formulating recommendations for Member States concerning new methods of industrial financing in the developing countries, through, inter alia, enterprise mechanisms and risk capital funds, the funds of various countries concentrated in the stock exchanges of the developing countries, and buildoperate-transfer (BOT) mechanisms;
 - (ii) To strengthen UNIDO activities in relation to pre-investment and investment, the negotiation of contracts and the financing of industrial projects, including the investment promotion programme, feasibility studies and the System of Consultations;
 - (iii) To improve, in cooperation with Member States and in coordination with the competent financial institutions and regional organizations, the present methods of industrial financing, and to find, within the sphere of UNIDO's competence, innovative approaches and proposals for projects which take into account, inter alia, debt servicing burdens and which are aimed at attenuating the negative effects of external debt on industrial development;
 - (iv) To ensure that in the planning, formulation and implementation of UNIDO activities, the debt problem be considered in connection with the priorities of developing countries as expressed in the medium-term plan;

- (j) Recalled the requests by developing countries that industrialized countries and international financial institutions should allocate substantially increased financial resources on concessional terms and conditions, aimed at accelerating the industrial development of the developing countries;
- Appealed to the Member States to continue their efforts to reduce substantially the external debt of the developing countries, particularly by writing off the debts of the least developed among them, and appealed to debtor countries to continue their efforts towards sustained growth by adopting appropriate economic policies;
- (1) Further requested the Director-General to present to the General Conference at its fifth session a report on the measures adopted and the progress achieved in implementing the present decision.
