I. ORGANIZATIONAL AND PROCEDURAL MATTERS

4. The President of the eleventh session of the Board, T. M. Machado Quintella (Brazil), presided over the resumed session.

Participation

5. The following 42 of the 53 members of the Board were represented at the session: Austria, Belarus, Belgium, Bolivia, Brazil, Cameroon, Chile, China, Costa Rica, Cuba, Egypt, Finland, France, Germany, Greece, Hungary, India, Indonesia, Iran (Islamic Republic of), Italy, Japan, Kuwait, Mexico, Morocco, Netherlands, Nigeria, Norway, Pakistan, Republic of Korea, Romania, Russian Federation, Saudi Arabia, Slovakia, Spain, Sudan, Switzerland, Thailand, Tunisia, Turkey, United Kingdom of Great Britain and Northern Ireland, United States of America, Venezuela.

6. The following 24 Member States of UNIDO also participated in the session: Algeria, Argentina, Australia, Bulgaria, Colombia, Croatia, Czech Republic, Democratic People's Republic of Korea, Denmark, Ecuador, Ireland, Jordan, Lebanon, Luxembourg, Oman, Panama, Philippines, Poland, Portugal, Qatar, Sweden, Ukraine, Uruguay, Yemen.

7. The Holy See participated as observer.

8. The United Nations Office at Vienna was represented.

9. The following other intergovernmental organization was represented: International Organization for Migration.

10. The following non-governmental organization was represented: Society of Chemical Industry.

Introduction

1. The report of the Industrial Development Board on the work of its resumed eleventh session of 22 November 1993 is presented to the General Conference in accordance with Article 9.4 (c) of the Constitution. The summary records of the session (IDB.11/SR.12), where details of the proceedings are contained, form an integral part of the present report.

2. The decision adopted by the Board at its resumed eleventh session (see para. 11 below) calls for action by the General Conference at its fifth regular session.

3. The resumed eleventh session of 22 November was held at UNIDO Headquarters, Vienna International Centre (1 plenary meeting - IDB.11/SR.12).

II. ADJUSTED PROPOSALS TO THE PROGRAMME  
AND BUDGETS, 1994-1995

IDB.11/Dec.43 PROGRAMME AND BUDGETS, 1994-1995

11. The Board had before it the adjusted proposals to the programme and budgets, 1994-1995, submitted by the Director on the basis of Industrial Development Board decision IDB.11/Dec.40 (IDB.11/32 and Corr.1). The debate on the subject is reflected in summary record IDB.11/SR.12. The Board considered a draft decision recommended by the Programme and Budget Committee in its conclusion 93/12 and adopted decision IDB.11/Dec.43 below. For statements made in connection with the adoption of the decision, see summary record IDB.11/SR.12.

The Industrial Development Board:

(a) Decided to submit to the General Conference for consideration and approval the programme and budgets for 1994-1995 as contained in document IDB.11/32-GC.5/14/Rev.1 and Corr.1

(b) Recommended to the General Conference the approval on the basis of an exchange rate of US\$ 1 = AS 12.90 of appropriations in the amount of \$229,320,200 for the regular budget of the Organization in 1994-1995 as reflected in the following table:

**Note:** The amounts presented in the table are to be adjusted in accordance with the adjustment formula presented at the end of the present decision to take account of exchange rate variations during the biennium.

(c) Also recommended to the General Conference that the foregoing net requirements be financed from payments of contributions by Member States under the provisions of financial regulation 5.5(e), amounting to \$196,310,300 at an exchange rate of US\$ 1 = AS 12.90 (\$23,557,200 plus the equivalent in US dollars of AS 2,228,514,990) in accordance with decisions to be adopted by the General Conference at its

fifth session concerning the scale of assessments;

(d) Further recommended to the General Conference the approval of estimates of expenditure totalling \$35,050,000 at an exchange rate of US\$ 1 = AS 12.90 for the purpose of the operational budget for the biennium 1994-1995 to be financed from voluntary contributions and such other income as might be provided for in the financial regulations.
