3. The fourteenth session of the Board was held at UNIDO Headquarters, Vienna International Centre, from 26 to 30 June 1995 (8 plenary meetings — see IDB.14/SR.1-8).

# A. UNIDO policy framework — organizational and staff structure

18. The Board had before it proposals by the Director-General on improving UNIDO programmes through a strengthened focus (IDB.14/13), a report by the Secretariat on personnel matters (IDB.14/8, chap. IV) and a conference room paper containing a synoptic review and outline for reporting to the sixth session of the General Conference on the reform process of Director-General **UNIDO** submitted the by (IDB.14/CRP.4). The Board also heard a statement by the representative of the tenth Staff Council (cf. IDB.14/SR.2, paras. 7-11). The Board considered a draft decision submitted by the President (IDB.14/L.3) and, with an amendment, adopted decision IDB.14/Dec.2 (see annex I).

20. The Board decided to discuss simultaneously agenda item 5 (Annual Report of the Director-General for 1994 on the activities of the Organization, including progress report on specific activities) and item 6 (UNIDO technical cooperation activities in 1994). The debate on the two agenda items is reflected in summary records IDB.14/SR.3, paragraphs 38-64, IDB.14/SR.4, paragraphs 3 to 108, and IDB.14/SR.5, paragraphs 1 to 13.

# A. Annual Report of the Director-General for 1994 on the activities of the Organization, including progress report on specific activities

21. The Board had before it the *Annual Report of UNIDO 1994* (IDB.14/10; IDB.14/10/Add.1 and Corr.1; IDB.14/10/Add.2 and Corr.1), a progress report on specific activities submitted by the Director-General (IDB.14/10/Add.3) and a list of resolutions and decisions adopted by the United Nations General Assembly, the Economic and Social Council and the Executive Board of the United Nations Development Programme/ United Nations Population Fund of relevance to UNIDO (IDB.14/CRP.5). The Board considered two draft decisions submitted by the President (IDB.14/L.4 and IDB.14/L.5) and adopted decisions IDB.14/Dec.3 and IDB.14/Dec.4 (see annex I).

# B. UNIDO technical cooperation activities in 1994

22. The Board had before it, in addition to the Annual Report of UNIDO 1994 (IDB.14/10; IDB.14/10/Add.1 and Corr.1; IDB.14/10/Add.2 and Corr.1), a report by the Director-General on UNIDO technical cooperation activities in 1994 (IDB.14/14), and a list of technical cooperation projects approved and/or operational in 1994 (IDB.14/CRP.1). The Board considered a draft decision submitted by the President (IDB.14/L.6) and adopted decision IDB.14/Dec.5 (see annex I).

# IV. REPORT OF THE PROGRAMME AND BUDGET COMMITTEE

# B. Interim financial performance report and programme performance report

25. The Board had before it the interim financial performance report (PBC.11/8 and Corr.1), and the interim programme performance report (IDB.14/10/Add.1 and Corr.1; IDB.14/10/Add.2 and Corr.1) for the biennium 1994-1995 submitted by the Director-General. At the suggestion of the President, the Board took note of that documentation (cf. IDB.14/SR.8, paras. 16 to 17).

#### C. Programme and budgets, 1996-1997

26. The Board had before it proposals of the Director-General for the programme and budgets, 1996-1997 (IDB.14/2 and Corr.1) as well as his proposals for improving UNIDO programmes through a strengthened focus (IDB.14/13). The Board considered a draft decision submitted by the President related also to the financial situation (IDB.14/L.26) and adopted decision IDB.14/Dec.7 (see annex I). For statements made in connection with the adoption of the decision, see summary record IDB.14/SR.8, paragraphs 20 to 28.

#### D. Working Capital Fund

27. The Board had before it proposals by the Director-General on the Working Capital Fund for the biennium 1996-1997 (IDB.14/3) and a report by the Director-General containing the status of advances to the Working Capital Fund as of 31 May 1995 (IDB.14/28, annex II). The Board considered a draft decision submitted by the President (IDB.14/L.8) and adopted decision IDB.14/Dec.8 (see annex I).

#### E. Appointment of External Auditor

28. The Board had before it Programme and Budget Committee conclusion 95/7 on appointment of an

external auditor (IDB.14/9, para. 17). The Board considered a draft decision submitted by the President (IDB.14/L.9) and adopted decision IDB.14/Dec.9 (see annex I).

#### F. Electronic data-processing programme

29. The Board had before it reports by the Director-General on the electronic data-processing programme of UNIDO (IDB.14/26) and a conference room paper containing a report on electronic networking arrangements for Permanent Missions (IDB.14/CRP.3). The Board considered a draft decision submitted by the President (IDB.14/L.10) and adopted decision IDB.14/Dec.10 (see annex I).

#### G. Financial situation of UNIDO

30. The Board had before it reports by the Director-General on the financial situation as of 31 May 1995 (IDB.14/28), on the 6 per cent figure set as a regular budget ceiling for technical cooperation activities (IDB.14/6 and Add.1) and on developments concerning the unified conference service (IDB.14/20). The Board adopted decision IDB.14/Dec.7 (see para. 26, above). The Board also considered two draft decisions submitted by the President (IDB.14/L.12 and IDB.14/L.24) and adopted decisions IDB.14/Dec.11 and IDB.14/Dec.12 (see annex I). For a statement made in connection with the adoption of decision IDB.14/Dec.12, see summary record IDB.14/SR.8, paragraph 38.

31. The Board considered a draft decision submitted by the President (IDB.14/L.14) and adopted decision IDB.14/Dec.18 (see annex I).

# B. Operational activities for development (General Assembly resolution 47/199, para. 51)

# VIII. PERSONNEL MATTERS; HEADQUARTERS AGREEMENT BETWEEN UNIDO AND THE REPUBLIC OF AUSTRIA; ADMINISTRATIVE MATTERS: JOINT INSPECTION UNIT; MATTERS RELATED TO INTERGOVERNMENTAL, NON-GOVERNMENTAL, GOVERNMENTAL AND OTHER ORGANIZATIONS

42. The Board decided to discuss simultaneously agenda item 13 (Personnel matters), with its subitems (a) and (b), item 14 (Headquarters agreement between UNIDO and the Republic of Austria), item 15 (Administrative matters: Joint Inspection Unit), and

item 16 (Matters related to intergovernmental, non-governmental, governmental and other organizations). The debate on the four agenda items is reflected in summary record IDB.14/SR.7, paragraphs 29 to 51.

#### A. Personnel matters; Women in the Secretariat

43. The Board had before it a report by the Secretariat on personnel matters (IDB.14/8), a conference room paper submitted by the Secretariat containing a list of staff of the UNIDO Secretariat as of 1 May 1995 (IDB.14/CRP.2) and information on the representation of women in the Secretariat contained in chapter IV of the *Annual Report of UNIDO 1994* (IDB.14/10) and in the interim programme performance report for the biennium 1994-1995 (IDB.14/10, Add.1, appendix L). The Board considered a draft decision submitted by the President (IDB.14/L.17) and adopted decision IDB.14/Dec.21 (see annex I).

#### B. United Nations Joint Staff Pension Fund

44. The Board had before it a report by the Secretariat on personnel matters (IDB.14/8). The Board considered a draft decision submitted by the President (IDB.14/L.22) and adopted decision IDB.14/Dec.22 (see annex I).

- (g) Requested the Director-General to assist in the preparation and implementation of a programme for entrepreneurial training and development, including, inter alia, the preparation of a business plan, the development of networks with foreign enterprises and the dissemination of information together with provision of advanced management training for local entrepreneurs as well as the development of sustainable institutional capabilities for this purpose in Africa;
- (h) Also requested the Director-General to accord high priority to the realization of the objectives set out in the Second IDDA, i.e. by reinforcing staff in the unit within the Secretariat;

- (e) Further requested the Director-General to promote and facilitate the establishment of Investment Promotion Service offices financed by extrabudgetary resources, such as from the Industrial Development Fund and other voluntary contributions;
- (f) Also requested the Director-General to continue:
  - (i) To improve the programme of assistance rendered by the Investment Promotion Service to the developing countries and to cooperate with interested parties with a view to mobilizing additional extrabudgetary resources to support investment promotion programmes for developing countries;
  - (ii) To expand investment appraisal and promotion activities— especially through development of investment projects and databases that allow international access to pre-investment studies carried out by the

United Nations system for which investment is being sought, and through the development of such investment vehicles in developing countries as mutual funds and venture capital funds.

# IDB.14/Dec.20 INDUSTRIAL INVESTMENT PROMOTION: GUIDELINES FOR THE FUNCTIONING OF THE INVESTMENT PROMOTION SERVICE OFFICES

The Industrial Development Board recommended to the General Conference the adoption of the following draft decision:

"The General Conference,

"Takes note of the report by the Director-General on industrial investment promotion (IDB.14/16-GC.6/5/Add.2) and decides to amend the Guidelines for the Functioning of the Investment Promotion Service Offices, approved in General Conference resolution GC.3/Res.19, as follows:

'The new text of paragraph 11 as approved in General Conference resolution GC.3/Res.19 should read:

#### "11. Funding arrangements for IPSOs

"IPSOs shall be financed by their host countries, who shall make voluntary contributions to UNIDO adequate to meet the costs to the Organization. The funding for all expenditures including the charge for programme support services (overhead charge) shall be provided in convertible currencies, except that in countries with non-convertible currency, funding for expenditures of IPSOs in local currency may be provided in such local currency, while the funding for all other expenditures including the charge for programme support services (overhead charge) shall be provided in convertible currency. A procedures and operations manual for the IPSOs shall be prepared.

"When requested by an interested country referred to in paragraph 4 above, UNIDO shall try to arrange extrabudgetary financing for the instalment and operating expenses of IPS offices established in developing countries. IPSOs may also raise additional resources by charging fees for services rendered on a cost-reimbursement basis."

'The new text of paragraph 12 as reflected in document GC.3/13 and approved in General Conference resolution GC.3/Res.19 should read:

#### "12. Personnel arrangements for IPSOs

"The Head of the IPSO will be appointed by the Director-General of UNIDO in accordance with the regulations, rules and procedures of UNIDO and after consultation with the host Government. UNIDO will operate and supervise the IPSO. The Head will either be appointed under the 200 series of the UNIDO staff rules and have the status of international project personnel or will be appointed as a locally recruited National Professional Officer, to whom the local salary scales apply as established by the International Civil Service Commission (ICSC) for this particular category of professional staff. For other staff, salaries will be determined on the basis of discussions between the host country and the UNIDO Secretariat."
