Introduction

- 1. The report of the Industrial Development Board on the work of its sixteenth session is presented to the General Conference in accordance with Article 9.4 (c) of the Constitution. The summary records of the Board (IDB.16/SR.1-5), where details of the proceedings are contained, form an integral part of the present report.
- 2. The following decision of the Board, reproduced in annex I, is related to the work of the General Conference:
 - IDB.16/Dec.2 Arrangements for the establishment of an international centre for hydrogen energy technologies.
- 3. The sixteenth session of the Board was held at UNIDO Headquarters, Vienna International Centre, from 20 to 22 November 1996 (5 plenary meetings see IDB.16/SR.1-5).

I. ORGANIZATIONAL AND PROCEDURAL MATTERS

Participation

- 4. - 5. II. ANNUAL REPORT OF THE DIRECTOR-GENERAL ON THE ACTIVITIES OF THE ORGANIZATION IN 1995, INCLUDING PROGRESS REPORT ON SPECIFIC ACTIVITIES; IMPLEMENTATION OF THE REFORM

17. The Board decided to discuss simultaneously agenda item 3 (Annual report of the Director-General on the activities of the Organization in 1995, including progress report on specific activities) and agenda item 4 (Implementation of the reform). The debate on the two items is reflected in summary records IDB.16/SR.1, paragraphs 30 to 112 and IDB.16/SR.2, paragraphs 4 to 140.

A. Annual report of the Director-General on the activities of the Organization in 1995, including progress report on specific activities

18. The Board had before it the Annual Report of UNIDO, 1995, including programme performance report for 1995 (IDB.16/10, Add.1, Add.2 and corrigendum) and a report by the Director-General on arrangements for the establishment of an international centre for hydrogen energy technologies (IDB.16/26). The Board considered a draft decision submitted by the President (IDB.16/L.2) and adopted decision IDB.16/Dec.2 (see annex I).

B. Implementation of the reform

19. The Board had before it a report by the Director-General on the implementation of the UNIDO reform: Action taken since April 1996 (IDB.16/18). The Board considered a draft decision submitted by the President (IDB.16/L.15) and adopted decision IDB.16/Dec.3 (see annex I).

III. REPORT OF THE PROGRAMME AND BUDGET COMMITTEE; MEDIUM-TERM PROGRAMME FRAMEWORK, 1998-2001 (INCLUDING GENERAL CEILING FOR THE BIENNIUM 1998-1999)

20. The Board decided to discuss simultaneously item 5 (and its subitems (a)-(g)) (Report of the Programme and Budget Committee) and item 10 (Medium-term programme framework, 1998-2001 (including general ceiling for the biennium 1998-1999)). The debate on the two agenda items is reflected in summary record IDB.16/SR.3, paragraphs 2 to 25.

A. Report of the Programme and Budget Committee

(i) Implementation of the programme and budgets, 1996-1997

21. The Board had before it a report by the Chairman of the Programme and Budget Committee, Mr. A. Celso de Ouro-Preto (Brazil) on the informal intersessional consultations on an in-depth examination of the programmatic contents of the revised programme and budgets for the biennium 1996-1997 (IDB.16/22) and a note by the Director-General on implementation of the programme and budgets, 1996-1997 (IDB.16/21). The Board considered a draft decision submitted by the President (IDB.16/L.8) and adopted decision IDB.16/Dec.4 (see annex I).

(ii) Financial situation of UNIDO

22. The Board had before it a report by the Director-General and a note by the Secretariat on the financial situation of UNIDO (IDB.16/7 and IDB.16/CRP.6), a report (IDB.16/9) and a note (IDB.16/CRP.2) by the Chairman (Mr. S. K. Lee, Republic of Korea) of the intersessional open-ended discussion group to study applicable measures to expedite timely payment of assessed contributions. The Board considered three draft decisions submitted by the President (IDB.16/L.9, IDB.16/L.10, IDB.16/L.11) and adopted decisions IDB.16/Dec.5, IDB.16/Dec.6 and IDB.16/Dec.7 (see annex I).

(iii) Report of the External Auditor, financial performance report and programme performance report for the biennium 1994-1995

23. The Board had before it the financial performance report for the biennium 1994-1995 submitted by the Director-General (IDB.16/8), the report of the External Auditor on the accounts of the United Nations Industrial Development Organization and of the Industrial Development Fund for the fiscal period 1994-1995

ended 31 December 1995 (IDB.16/2) and the comments of the Director-General thereon (IDB.16/4), and the Annual Report of UNIDO 1995 (including programme performance report for 1995) (IDB.16/10, Add.1, Add.2 and corrigendum). The Board considered a draft decision submitted by the President (IDB.16/L.19) and adopted decision IDB.16/Dec.8 (see annex I).

(iv) Financial regulations

24. The Board had before it a report by the Director-General on financial regulations (IDB.16/6 and Add.1). The Board considered a draft decision submitted by the President (IDB.16/L.12) and adopted decision IDB.16/Dec.9 (see annex I).

(v) Industrial Development Fund and other voluntary contributions

25. The Board had before it a report by the Director-General on the Industrial Development Fund—Estimated resource level and programme for 1997-1998 (IDB.16/3), information on the nature of projects financed from the Industrial Development Fund, contained in the Annual Report of UNIDO 1995 (IDB.16/10/Add.1 and corrigendum, appendix C), information on the nature of projects financed from third party and self-financed trust funds, contained in the Annual Report of UNIDO 1995 (IDB.16/10/Add.1 and corrigendum, appendix D). The Board considered a draft decision submitted by the President (IDB.16/L.13) and adopted decision IDB.16/Dec.10 (see annex I).

(vi) Ceiling of assessments

26. At the suggestion of the President, the Board took note of the information provided by the Secretariat in the annotated provisional agenda on agenda item 5 (f) (IDB.16/1/Rev.1/Add.1) (IDB.16/SR.5, paras. 22-23).

(vii) Withdrawal of the United States of America from UNIDO

27. The Board had before it a note by the Secretariat on the withdrawal of the United States of America from UNIDO: Some legal and financial implications (IDB.16/5 and Corr.1). The Board considered a draft decision submitted by the President (IDB.16/L.14) and adopted decision IDB.16/Dec.11 (see annex I).

B. Medium-term programme framework, 1998-2001 (including general ceiling for the biennium 1998-1999)

28. The Board had before it the proposals of the Director-General for the draft medium-term programme framework, 1998-2001 (IDB.16/23) and a preview of

the first biennium 1998-1999 and preliminary indicative general ceiling submitted by the Director-General (IDB.16/23/Add.1). The Board considered a draft decision submitted by the President (IDB.16/L.17) and adopted decision IDB.16/Dec.12 (see annex I).

IV. SECOND INDUSTRIAL DEVELOPMENT DECADE FOR AFRICA; INDUSTRIALIZATION OF THE LEAST DEVELOPED COUNTRIES; FIELD REPRESENTATION; INDUSTRIAL INVESTMENT PROMOTION

29. The Board decided to discuss simultaneously agenda item 6 (Second Industrial Development Decade for Africa), item 7 (Industrialization of the least developed countries), item 8 (Field representation) and item 9 (Industrial investment promotion). The debate on the four agenda items is reflected in summary record IDB.16/SR.3, paragraphs 26 to 183.

A. Second Industrial Development Decade for Africa

30. The Board had before it a note by the Secretariat on the Second Industrial Development Decade for Africa (IDB.16/15) and a report by the Director-General on the Alliance for Africa's Industrialization (IDB.16/16 and Add.1). The Board considered a draft decision submitted by the President (IDB.16/L.3) and adopted decision IDB.16/Dec.13 (see annex I).

B. Industrialization of the least developed countries

31. The Board had before it a report by the Director-General on implementation of the UNIDO programme for the least developed countries (IDB.16/13). The Board considered a draft decision submitted by the President (IDB.16/L.4) and adopted decision IDB.16/Dec.14 (see annex I).

C. Field representation

32. The Board had before it a report by the Director-General on UNIDO field representation (IDB.16/19). The Board considered a draft decision submitted by the President (IDB.16/L.5) and adopted decision IDB.16/Dec.15 (see annex I).

D. Industrial investment promotion

33. The Board had before it a report by the Director-General on industrial investment promotion (IDB.16/11) and a note by the Secretariat on activities of the UNIDO Investment Promotion Services (IDB.16/CRP.5). The Board considered a draft decision submitted by the President (IDB.16/L.6) and adopted decision IDB.16/Dec.16 (see annex I).

V. JOINT INSPECTION UNIT

34. The Board had before it a note by the Secretariat on activities of the Joint Inspection Unit of relevance to UNIDO (IDB.16/12). The debate on item 11 is reflected in summary record IDB.16/SR.3, paragraphs 184 to 186. At the suggestion of the President, the Board took note of the information provided by the Secretariat (IDB.16/SR.5, paras. 36-37).

VI. UNIDO CONTRIBUTION TO THE SYSTEM-WIDE ACTION PLAN ON DRUG ABUSE CONTROL

35. The Board had before it a report by the Director-General on the UNIDO contribution to the System-Wide Action Plan on Drug Abuse Control (IDB.16/14). The debate on item 12 is reflected in summary records IDB.16/SR.3, paragraphs 187 to 191 and IDB.16/SR.4, paragraphs 21 to 41. The Board considered a draft decision submitted by the President (IDB.16/L.7) and adopted decision IDB.16/Dec.17 (see annex I).

VII. PERSONNEL MATTERS; APPOINTMENT OF MANAGING DIRECTORS

36. The Board decided to discuss simultaneously agenda item 13 (Personnel matters) and 14 (Appointment of Managing Directors). The debate on the two agenda items is reflected in summary records IDB.16/SR.3, paragraphs 192 to 227 and IDB.16/SR.4, paragraphs 1 to 20.

A. Personnel matters

37. The Board had before it a note by the Secretariat on personnel matters (IDB.16/17) and a list of staff of the UNIDO Secretariat as of 1 November 1996, submitted by the Secretariat (IDB.16/CRP.1). The Board considered a draft decision submitted by the President (IDB.16/L.16) and adopted decision IDB.16/Dec.18 (see annex I).

B. Appointment of Managing Directors

VIII. PREPARATIONS FOR THE SEVENTH SESSION OF THE GENERAL CONFERENCE

39. The Board had before it a note by the Secretariat on the preparation of the provisional agenda for the seventh session of the General Conference (IDB.16/20) and a note by the Secretariat on the term of office of the current Director-General and procedures for nomination and appointment to the post of Director-General (IDB.16/CRP.3). The debate on item 15 is reflected in summary records IDB.16/SR.4, paragraphs 42 to 45 and IDB.16/SR.5, paragraphs 46 to 49. The Board agreed to include additional agenda items entitled "Geographical distribution of Managing Directors" and "Industrial investment promotion" in the list of items of the draft provisional agenda for the seventh session of the General Conference, contained in the annex to document IDB.16/20 (see summary records IDB.16/SR.4, paras. 42-43 and IDB.16/SR.5, paras. 48-49).

IX. PROVISIONAL AGENDA AND DATE OF THE SEVENTEENTH SESSION

40. The Board had before it a note by the Director-General on the provisional agenda and date of the seventeenth session (IDB.16/CRP.4). The Board considered a draft decision submitted by the President (IDB.16/L.18) and adopted decision IDB.16/Dec.19 (see annex I) (see summary record IDB.16/SR.5, paras. 50-58).

X. ADOPTION OF THE REPORT OF THE SIXTEENTH SESSION

41. The Board considered the draft report (IDB.16/L.1) and adopted it as a whole with the understanding that

the Rapporteur would be entrusted with the task of finalizing the report (see summary record IDB.16/SR.5, paras. 59-61).

XI. CLOSURE OF THE SIXTEENTH SESSION

42. On 22 November, the President made the following statement (see summary record IDB.16/SR.5, para. 72):

"I have noted with great concern the recent press statement emanating from a member of the Government of the Federal Republic of Germany suggesting that Germany might withdraw from UNIDO. The Federal Republic of Germany is one of the major contributors and has indeed been showing great commitment to its programmes and activities.

"The news of such a possibility has aroused a vivid concern among UNIDO Member States and they hope that Germany will continue to play an active role in UNIDO which serves as a specialized agency in the United Nations system mandated to promote multilateral industrial development cooperation.

"I therefore wish to appeal to the Government of the Federal Republic of Germany to continue to play this role."

- 43. Statements on the same issue were also made by the representatives of Pakistan (on behalf of the Group of 77), Sudan (on behalf of the African Group), Argentina (on behalf of the Latin American and Caribbean Group), Japan, China and Turkey (see summary record IDB.16/SR.5, paras. 62-71).
- 44. On 22 November, at 6.58 p.m., the Board closed its sixteenth session.

IDB.16/Dec.2 ARRANGEMENTS FOR THE ESTABLISHMENT OF AN INTERNATIONAL CENTRE FOR H Y D R O G E N E N E R G Y TECHNOLOGIES

The Industrial Development Board:

- (b) Requested the Director-General to pursue the discussions with the Turkish authorities for the eventual establishment and long-term operation of the centre:
- (c) Further requested the Director-General to submit a report to the Board at its seventeenth session on the progress made in the establishment of the centre;
- (d) Invited the General Conference at its seventh session to take note of the present decision.

IDB.16/Dec.3 IMPLEMENTATION OF THE UNIDO REFORM

The Industrial Development Board:

- (a) Recalled General Conference resolutions GC.5/Res.18 and GC.5/Res.20 and Industrial Development Board decision IDB.15/Dec.2;
- (b) Took note of the report of the Director-General contained in document IDB.16/18;
- (c) Welcomed the intention of the Director-General to establish cooperation with the International Business Advisory Council;
 - (d) Requested the Director-General:
 - (i) To pay due regard to resolution GC.6/Res.1;
 - (ii) To improve internal coordination;
 - (iii) To continue to focus activities on those areas where UNIDO has a comparative advantage, within the seven thematic priorities;
 - (iv) To indicate in detail what he expects to achieve through the cooperation with the International Business Advisory Council;
 - (v) To make efforts towards implementing the activitiesmentioned in paragraphs d(ii) and d(iii) of decision IDB.15/Dec.2;
- (e) Urged the Director-General to improve the balance between resources allocated to substantive programmes and those allocated to administrative activities, and to continue to implement the UNIDO reform process on the basis of high-quality monitoring and evaluation of programmes as well as through the establishment of demand- and result-oriented planning and budgeting systems;

be implemented in the light of the new priority given to Africa within the seven thematic priorities of UNIDO;

- (e) Recalled that good governance, healthy macroeconomic management and the strengthening of institutional and human capacity are among the elements that contribute to a stable environment in which to promote investment:
- (f) Considered that addressing the specific problem of the industrialization of African countries should continue to be one of the main priorities of UNIDO's activities;
- (g) Welcomed the recent launching of the Alliance for Africa's Industrialization at Abidjan, Côte d'Ivoire, on 23 October 1996 as a dynamic mechanism for the attainment of the goals and objectives of IDDA;
- (h) Encouraged the Director-General to support the efforts of African Governments, African economic and financial regional and subregional institutions and African private operators, to translate into concrete measures this initiative, *inter alia*, by:
 - (i) Clearly defining industrial development strategies and programmes at the national and regional level in order to secure firstly food security, employment and environmental protection, and to attain long term industrial growth and competitiveness;
 - (ii) Supporting the integration of Africa's informal sector into the mainstream of formal industry;
 - (iii) Inducing the support from Africa's development partners and the international community, *inter alia*, through promotion of foreign investment and development of human resources, especially the development of entrepreneurship of women;
 - (iv) Facilitating the setting up of industrial partnerships to build, as a first step, a sustainable agro-industrial base and supporting where possible the privatization of local industry;
 - (i) Requested the Director-General:
 - (i) To submit to the Industrial Development Board at its seventeenth session a more detailed report on the Alliance for Africa's Industrialization in which a clear managerial

- and financial structure of the Alliance and its linkages with IDDA would be provided, to ensure a coherent and consistent approach.
- (ii) To take appropriate measures to mobilize the necessary funds to sustain the Alliance.

IDB.16/Dec.14 INDUSTRIALIZATION OF THE LEAST DEVELOPED COUNTRIES

The Industrial Development Board:

- (a) Recalled General Conference resolution GC.6/Res.8 and Industrial Development Board decision IDB.15/Dec.7;
- (b) Took note of the Paris Declaration and Programme of Action of the United Nations Conference on the Least Developed Countries, the outcome of the World Summit for Social Development, the Ministerial Declaration of the Group of 77, New York, of 29 September 1995;
- (c) Emphasized the need to support sustainable development of the private sector in the least developed countries and to accelerate the growth of industrial enterprises for expediting their industrial development;
- (d) Also took note of the information on the implementation of the least developed countries projects as contained in the report of the Director-General (IDB.16/13);
- (e) Further took note with concern of the general lack of progress in the industrialization of the least developed countries, particularly in Africa, and the continued deterioration of their economic, social and ecological situation;
 - (f) Requested the Director-General:
 - (i) To accord highest priority to the implementation of the least developed countries programmes, taking into account the conclusions and recommendations of both the Second and the Third Ministerial Symposia on the Industrialization of the Least Developed Countries, through optimizing the use of available funds;

- (ii) To intensify efforts to mobilize funds for industrialization of the least developed countries;
- (iii) To further intensify efforts in the area of industrial investment promotion in the least developed countries;
- (iv) To further enhance the programmes of assistance rendered by UNIDO to the least developed countries directed to developing ecologically sustainable industrial programmes;
- (v) To continue to report on the implementation of the projects in the least developed countries.

 - (ii) To consider, where appropriate, alternatives that might be proposed;
 - (iii) To make appropriate provisions in the programme and budget proposals for the 1998-1999 biennium, at a level not below that of the present biennium, for the redeployment of posts to the field;
 - (iv) To develop a clear conceptual basis for the programme, including a handbook to guide field office personnel;
 - (v) To implement gradually the new approach over the next two years;
 - (vi) To submit a progress report on the ways and means in which the present recommendations are being implemented to the Board at its seventeenth session.
