Introduction

1. The report of the Industrial Development Board on part one of the work of its eighteenth session is presented to the General Conference in accordance with Article 9.4 (c) of the Constitution. The summary records of the session (IDB.18/SR.1-2), where details of the proceedings are contained, form an integral part of the present report.

2. The decision adopted by the Board at its eighteenth session, reproduced in annex I, calls for action by the General Conference at its seventh session:

IDB.18/Dec.1 Recommendation of a candidate for the post of Director-General

3. Part one of the eighteenth session of the Board was held at UNIDO Headquarters, Vienna International Centre, on 12 September 1997 (2 plenary meetings—see IDB.18/SR.1-2).

4. Part one of the eighteenth session of the Board was declared open by the President of the seventeenth session, Mr. I. Posta (Hungary).

5. In accordance with rule 24.2 of its rules of procedure, Mr. H. Wøhlk (Denmark) was elected as Vice-President to succeed Mr. J. R. H. Bøjer (Denmark), who had left Vienna.

6. In accordance with rule 23 of its rules of procedure, the other officers of the Board were those elected at the commencement of the first regular session in 1997: Mr. A. Velazco San José (Cuba), Mr. A. A. Halim Mohamed (Sudan) as Vice-Presidents and Mr. A. R. Tootoonchian (Islamic Republic of Iran) as Rapporteur.

The following 51 of the 53 members of the Board were represented at the session: Algeria, Argentina, Austria, Belgium, Brazil, Bulgaria, China, Colombia, Côte d'Ivoire, Cuba, Denmark, Ecuador, Egypt, France, Germany, Ghana, Greece, Hungary, India, Indonesia, Iran (Islamic Republic of), Italy, Japan, Kenya, Lebanon, Mexico, Morocco, Netherlands, Nicaragua, Nigeria, Pakistan, Paraguay, Peru, Philippines, Poland, Portugal, Qatar, Republic of Korea, Romania, Russian Federation, Saudi Arabia, Spain, Sudan, Sweden, Switzerland, Tunisia, Turkey, Uganda, United Arab Emirates, United Kingdom of Great Britain and Northern Ireland and Zambia.

The following 45 Member States of UNIDO also participated in the session: Angola, Australia, Azerbaijan, Bangladesh, Belarus, Bolivia, Bosnia and Herzegovina, Chile, Costa Rica, Croatia, Cyprus, Czech Republic, Democratic People's Republic of Korea, Ethiopia, Finland, Gabon, Guatemala, Haiti, Iraq, Ireland, Jordan, Kazakhstan, Kuwait, Kyrgyzstan, Lesotho, Liberia, Libyan Arab Jamahiriya, Luxembourg, Madagascar, Malaysia, New Zealand, Norway, Oman, Panama, Republic of Moldova, Slovakia, Slovenia, Sri Lanka, Thailand, the former Yugoslav Republic of Macedonia, Ukraine, Uruguay, Venezuela, Yemen and Zimbabwe.

13. The following intergovernmental organizations were represented: International Organization for Migration, League of Arab States and Organization of African Unity.

14. The following non-governmental organizations were represented: Austrian Society for Environment and

Technology, European Union of Public Relations, International Confederation of Free Trade Unions, International Organisation of Employers and World Association for Small and Medium Enterprises.

II. RECOMMENDATION OF A CANDIDATE FOR THE POST OF DIRECTOR-GENERAL

15. The Board had before it a note by the Secretariat on the appointment of the Director-General (IDB.18/6). In accordance with rule 61 of its rules of procedure, the Board considered in private meetings the nominations for the post of Director-General. The Board considered a draft decision submitted by the President (IDB.18/L.2) and adopted decision IDB.18/Dec.1 (see annex I).

16. The Board also had before it a note by the Secretariat containing a draft contract for the appointment of the Director-General (IDB.18/7). The Board considered a draft decision submitted by the President (IDB.18/L.3) and decided to consider the matter at its resumed eighteenth session. The debate on the subject is reflected in summary record IDB.18/SR.2, paragraphs 3 to 6.

III. ADOPTION OF THE REPORT AND SUSPENSION OF PART ONE OF THE EIGHTEENTH SESSION

17. The Board entrusted the Rapporteur with the task of finalizing the report (see summary record IDB.18/SR.2, paras. 13-14), and suspended its eighteenth session on 12 September 1997 at 6.30 p.m.

**IDB.18/Dec.1 RECOMMENDATION OF A CANDIDATE FOR THE POST OF
DIRECTOR-GENERAL**
