## Organization of work

- 15. The Board adopted a proposal by the President to improve the utilization of available conference-servicing resources (see annex I, decision IDB.3/Dec.1).
- 16. Upon adoption of the agenda, the Board decided to establish an open-ended sessional working group on item 9, under the chairmanship of Vice-President K. Zeller (Federal Republic of Germany), to review the preparatory arrangements for the second session of the General Conference on the basis of the report of the Director-General on the subject (IDB.3/27) and submit its recommendations to the Board.
- 17. In view of the short duration and heavy work-load of the third session, and following a proposal by the President under rule 43 of its rules of procedure, the Board agreed to permit the discussion and consideration of draft decisions which had not been circulated or had only been circulated on the day they were being brought to its consideration.

## Rules of procedure

18. The Board deferred the consideration of provisional rule 61 of its rules of procedure and established an inter-sessional working group to review the rule (see annex I, decision IDB.3/Dec.2).

## II. GENERAL DEBATE

- 19. The general debate covered the annual report on the activities of the Organization, including the special programmes listed under sub-items 5(a) to (k) of the agenda.
- 20. The Board had before it the Annual Report of UNIDO, 1986 (IDB.3/10), a list of resolutions and decisions of relevance to UNIDO that were adopted in 1986 by the United Nations General Assembly and Economic and Social Council and the Governing Council of the United Nations Development Programme (IDB.3/CRP.3) and the documents mentioned under the special programmes below. A detailed account of statements made during the debate is given in the summary records (IDB.3/SR.1-4).

21. The Board had before it a note by the Director-General with a progress report on the implementation of the programme of the Industrial Development Decade for Africa (IDB.3/20) and the annual report (IDB.3/10, chap. IV, paras. 1-7). The Board considered a draft decision submitted by the African Group and adopted decision IDB.3/Dec.3 (see annex I).

## B. Restructuring of world industrial production and redeployment

22. The Board had before it a report by the Director-General (IDB.3/25). The Board considered a draft decision submitted by the President and adopted decision IDB.3/Dec.4 (see annex I).

The Board considered a draft decision submitted by the President and adopted decision IDB.3/Dec.5 (see annex I).

# D. Development and transfer of technology, including the Industrial and Technological Information Bank

24. The Board had before it the annual report (IDB.3/10, chap. III, paras. 18-41) and a report by the Director-General (IDB.3/26). The Board considered a draft decision submitted by the President and adopted decision IDB.3/Dec.6 (see annex I).

## III. REPORT OF THE PROGRAMME AND BUDGET COMMITTEE

35. The Board considered the report of the Programme and Budget Committee (PBC) on the work of its third session (IDB.3/2 and Add.1), in particular those conclusions drawn to its attention in paragraph 7 of document IDB.3/2 and in paragraph 6 of IDB.3/2/Add.1.

# A. Scale of assessments for apportionment of the regular budget expenses of UNIDO

36. The Board considered PBC conclusion 1987/4, a note by the Secretariat (PBC.3/4), a status report by the Secretariat (IDB.3/30-PBC.3/15) and an update of the status report (IDB.3/CRP.8) and adopted decision IDB.3/Dec.17 (see annex I).

## B. Programme and budgets, 1988-1989

- 37. The Board had before it proposals submitted by the Director-General (PBC.3/2 and Add.1, PBC.3/CRP.12, 13, 14, 16 and PBC.3/18), a report of the informal open-ended working group of the PBC (IDB.3/CRP.1-PBC.3/CRP.15) and a note by the Chairman of the working group (IDB.3/29-PBC.3/14).
- 38. The Board considered the recommendations on the programme and budgets, 1988-1989 contained in PBC conclusion 1987/19. A roll-call vote was taken, at the request of Brazil, on the recommendation contained in paragraph (c) of the PBC conclusion. By 32 votes to 12, with 4 abstentions, the recommendation was adopted (for details, see IDB.3/SR.6, paras. 4-6). The Board adopted decision IDB.3/Dec.18 (see annex I).
- 39. The Board considered PBC conclusion 1987/20 on measures to stabilize the operational budget and PBC conclusion 1987/11 on the programme and budget planning process and adopted decisions IDB.3/Dec.19 and IDB.3/Dec.20 (see annex I).

## C. Medium-term plan, 1990-1995

40. The Board had before it PBC conclusion 1987/14 and a note by the Director-General (IDB.3/4). The Board considered a draft decision submitted by the President and adopted decision IDB.3/Dec.21 (see annex I).

41. The Board had before it a recomputation of the net requirements of UNIDO for the biennium 1986-1987 submitted by the Director-General (IDB.3/31-PBC.3/16), a report of the informal open-ended working group of the PBC (IDB.3/CPP.1-PBC.3/CRP.15), a note by the Chairman of the working group (IDB.3/29-PBC.3/14), proposals by the Director-General regarding repayment of the United Nations loan to UNIDO (IDB.3/32-PBC.3/17), a status report by the Secretariat (IDB.3/30-PBC.3/15) and an update of the status report (IDB.3/CRP.8) and decision 1987/2 of the Administrative Committee on Co-ordination. The Board considered PBC conclusion 1987/7 on split-currency system of assessment and PBC conclusion 1987/18 on repayment of the United Nations loan to UNIDO and adopted decisions IDB.3/Dec.22 and IDB.3/Dec.23 (see annex I).

    - (d) Further decided to:
    - (i) Reaffirm the importance of the Industrial Development Decade for Africa (IDDA);
  - (ii) Take note of the special-purpose contributions made and/or pledged hitherto for financing IDDA-related activities for the current biennium and for the biennium 1988-1989, amounting to over \$9 million;
  - (iii) Request the Director-General to establish within the Industrial Development Fund a special account for financing IDDA-related activities;
  - (iv) Request the Director-General to identify, at the request of interested Member States, IDDA-related projects suitable for financing or co-financing by those States;
  - (v) In recognition of the importance of IDDA, urge Member States to contribute generously and with as few conditions as possible to the financing of IDDA-related projects either in the form of contributions to the special account or otherwise;
- (e) Decided to recommend to the Conference that, from the total amount of the 1988-1989 appropriations,

an amount representing 15 per cent of those appropriations should be kept in reserve by the Director-General, pending receipt from Member States of their assessed contributions;

- (f) Also decided to recommend to the Conference that the net allocation of \$116,563,900 be the assessment of Member States to be apportioned in accordance with the scale of assessments adopted by the United Nations General Assembly applicable for the years 1988 and 1989, subject to any adjustment necessary as a result of applying the United Nations operational rate of exchange in effect in November 1987 for the programme budget, but excluding from that adjustment the dollar-based items of expenditure;

The working group on agenda item 9 of the third session of the Industrial Development Board, which has been set up on your request to review the preparatory

arrangements for the second session of the General Conference on the basis of document IDB.3/27, has finalized its work with the following results and recommendations to the Board related to subparagraphs 21 (a), (b), (c) and (d), chapter IX (Action required of the Board), of that document:

- (a) The working group recommends to the Industrial Development Board to finalize the provisional agenda for the second session of the General Conference as contained in annex I of document IDB.3/27:
- (b) The working group recommends to the Board to take note of the documentation as proposed by the Secretariat in paragraph 17 of document IDB.3/27. It has taken note that the Secretariat will also prepare issue papers on:
  - (i) Human resources development for industrialization;
  - (ii) UNIDO's co-ordinating role in the United Nations system in industrial development;
  - (iii) Policies for industrial recovery and growth in developing countries.

As far as item 8 of the provisional agenda for the General Conference (mobilization of financial resources for industrial development) is concerned, the document available is the draft resolution of the Fourth General Conference of UNIDO that is being reverted through the General Assembly to UNIDO. The Secretariat, on the strong requests of certain delegations in the working group, will prepare a brief updated issue paper on the subject.

Item 9 (the external debt and industrial development) will be covered for the time being from the Secretariat's side by the executive summary of Industry and Development: Global Report, 1987, as well as by the above-mentioned issue paper on policies for industrial recovery and growth in developing countries.

The Secretariat is ready to prepare additional issue papers, if necessity should arise, taking into account time and financial constraints;

(c) The working group assumed that the first day of the plenary of the General Conference will be mainly devoted to general matters and the elections to organs. Taking into consideration that at the end of the Conference reports must be delivered to and decisions taken by the General Conference for which one and a half days should be reserved, the working group takes it that two and a half days, i.e.

15 hours, will be available for the general debate. The working group recommends that only one round of general debate take place in the plenary, and notes that each of the delegations will not have more than seven minutes' time available for its statement.

Under these conditions the statements will therefore cover items 7-15 of the provisional agenda.

Time for short statements of representatives of the United Nations, its agencies, intergovernmental organizations and non-governmental organizations will be accommodated after the statements of the delegations in the time frame allotted for the debate and this as far as possible.

The main committee of the General Conference will meet from the afternoon of Monday, 9 November 1987, onwards and hold five meetings of half a day each as proposed by the Secretariat. The following items of the provisional agenda should be deliberated in the main committee: 7(a), 7(d), 7(g), 8, 9 and financial and administrative matters.

(d) The working group follows the recommendation of the Secretariat that the summary records of the Conference be issued in English only during the session, while the translations could be produced later in Vienna.

It adds, however, its wish that the translations of the documentation in languages other than English, be delivered in Vienna with utmost diligence.

Furthermore, the working group recommends that representatives of permanent missions in Vienna set up a contact group for the preparation of the General Conference. This group should report on its work to the Industrial Development Board at its resumed third session on 12 October 1987.

#### Annex

UNITED NATIONS INDUSTRIAL DEVELOPMENT ORGANIZATION

In their application to the United Nations Industrial Development Organization (hereinafter called "the Organization") the standard clauses shall operate subject to the following modifications:

- 1.(a) Experts (other than officials coming within the scope of article VI) serving as committees of, or performing missions for, the Organization shall be accorded the following privileges and immunities so far as is necessary for the effective exercise of their functions, including the time on journeys in connection with service on such committees or missions:
  - (i) Immunity from personal arrest or detention and from seizure of their personal baggage;
  - (ii) In respect of words spoken or written or acts done by them in the performance of their official functions, immunity from legal process of every kind, such immunity to continue notwithstanding that the person concerned is no longer serving on committees of, or employed on mission for, the Organization;
  - (iii) The same facilities in respect of currency and exchange restrictions and in respect of their personal baggage as are accorded to officials of foreign Governments on temporary official missions;

- (iv) Inviolability for all papers and documents;
- (v) For their communications with the Organization, the right to use codes and to receive documents and correspondence by courier or in sealed bags;
- (b) In connection with subparagraphs (iv) and (v) of paragraph 1(a) above, the principle contained in the last sentence of section 12 of the standard clauses shall be applicable;
- (c) Privileges and immunities are granted to experts of the Organization in the interests of the Organization and not for the personal benefit of the individuals themselves. The Organization shall have the right and duty to waive the immunity of any expert in any case where in its opinion the immunity would impede the course of justice, and it can be waived without prejudice to the interests of the Organization;
- The privileges, immunities, exemptions and facilities referred to in section 21 of the standard clauses shall also be accorded to any Deputy Director-General of the Organization.
