Update of summary for 3rd plenary meeting (morning)

General debate – Items 7 to 20 (*continued*)

During the 3rd plenary, statements were made by representatives of Islamic Republic of Iran (on behalf of the Group of 77 and China), Poland (on behalf of the European Union), Algeria (on behalf of the African Group), Thailand (on behalf of the Asia and Pacific Group), Costa Rica (on behalf of GRULAC), Sudan, Germany, Russian Federation, France, Saudi Arabia and Ukraine.

5th plenary meeting (morning)

General debate – Items 7 to 20 (*continued*)

With the Vice-President in the Chair (Zimbabwe), statements were made by representatives of Comoros, Syrian Arab Republic, Uruguay, Italy, Honduras, Jordan, Democratic People's Republic of Korea, Finland, Armenia, Brazil, Indonesia, Sri Lanka, Côte d'Ivoire and Egypt.

Main Committee – 3rd meeting

The draft resolution on youth employment under item 13 was introduced by the representative of Nigeria.

6th plenary meeting (afternoon)

General debate – Items 7 to 20 (*continued*)

With the President in the Chair, statements were made by representatives of Serbia, Mongolia, Belarus, Mozambique, Lesotho, Lao People's Democratic Republic, Ghana, Zambia, United Republic of Tanzania, El Salvador, Algeria and Zimbabwe.

Main Committee – 4th meeting

Under item 10 (b), the Committee adopted a Chairman's proposal on unutilized balances to strengthen UNIDO programmes, for consideration by the plenary. The Committee also recommended the draft resolution on youth employment to plenary for adoption.
