**Agenda Item 3  
Annual Report of the Director General for 2012**

**Mr. President,**

1. The Asia and Pacific Group takes note of the document IDB.41/2-PBC.29/2 regarding the 2012 Annual Report of the Director General of UNIDO and appreciates the work done by the secretariat for its finalization. The Group acknowledges UNIDO's efforts in the promotion of sustainable industrial development, and looks forward to further effective implementation of activities and programs that fosters industrial development and eradicates poverty in the region.
2. The Group values the key role played by UNIDO at the United Nations Conference on Sustainable Development (Rio+20) and welcomes the outcome document of the Rio+20, in this regard; the Group encourages UNIDO to take an active role in setting

sustainable development goals (SDGs) that will provide a new framework for global development.

3. The Group notes with interest that the level of shares of submitted projects by region has increased in the Asia and Pacific region to 20%, compared to 17% in 2011. In this regard, the group encourages UNIDO to further foster the submission of projects in the Asia and Pacific region and particularly the Arab sub-region.
4. The Group takes note that the level of fund mobilization and sources of funding in comparison with previous years remain stable. However, the Group is concerned about the non-equitable allocation of the resources and calls for the optimal and balanced utilization of funds among the three thematic areas.

**Programme and Budgets, 2014-2015**

**Mr. President,**

1. The Asian and Pacific Group recommends to the Board the approval of the Programme and Budgets 2014-2015, Revised Proposals by the Director General, and of Conclusion 2013/3 of the 29th Session of the Programme and Budget Committee. In particular, the Group recommends the approval of estimates of regular budget gross expenditures of €147.2 million to be financed from assessed contributions in the amount of €143.7 million and other income of €3.5 million.
2. The Group appreciates the efforts of the Secretariat in presenting a reduced regular budget for 2014-2015, including in applying the principle of minimizing the negative

programmatic impact and preserving the Organization's capacity to deliver technical cooperation. The Group welcomes the sustained pursuit of efficiency gains and cost-savings in the operations of the UNIDO and in the implementation of its activities.

**Agenda Item 6**  
**Medium-term programme framework**

**Mr. President,**

1. The Asia and Pacific Group reiterates its understanding of the reasons behind the Director General's proposal to extend work with the current MTPF 2010-2013 until the expiry of the forthcoming biennium 2014-2015.
2. However, taking into consideration the substantial efforts of the informal working group on the future, including programmes and resources, of UNIDO which produced a valuable final document, the Group would like to invite the Director General and the Secretariat while elaborating a new MTPF, to consider and implement the guidelines and recommendations provided by the informal working group as well as whenever appropriate, the recommendations stemming from the ongoing QCPR deliberations.
3. Meantime and until the expiry of the biennium 2015, bearing in mind that the MTPF is a revolving four-year document updated every two years in order to represent the programmatic and managerial response of the Organisation to the emerging challenges, the Group would like as well to request the Director General and the Secretariat to undertake a midterm biennial review of the extended MTPF taking into consideration the guidelines and recommendations provided by the informal working group on the future of UNIDO as well as the conclusions of the QCPR process.

**Mr. President,**

1. The Asia and Pacific Group highly appreciates the great generosity offered by the Government of Peru to host the 15<sup>th</sup> session of the General Conference in December 2013, and will make joint efforts with other groups to ensure the full success of the event.
2. The Group considers that the process of industrialization and reindustrialization, *inter alia*, are continuing to play a pivotal role in driving the sustainable growth and poverty eradication, and it is recognized that UNIDO is the sole agency aiming to promote sustainable industrial developments under the umbrella of the United Nations systems.
