Ensuring safer food and preventing global food scandals are not only a national issue with food being traded through largely fragmented value chains. Increasingly, food safety and enforcement of regulations and standards will depend on building the right partnerships between regulators and industry at global, regional and national level.

Food risk management tools, such as the emergency response system, have vital roles in addressing risk within the dairy sector. Session 3 – Panel Discussion: Industry Engagement in Food Safety Capacity Building

Industry has a major role in guaranteeing efficiency and effectiveness of food supply systems and ensuring that it results in a supply of safe food products. Many small-scale suppliers have difficulties to adequately respond to market requirements, which



prevent them from seizing business opportunities with local, regional and global buyers. By developing the supply-side through food safety capacity building, there will be an overall improvement of management, quality, safety, productivity and sustainability practices within the food industry that, in turn, will positively impact their overall business, environmental and social performance.

The panel discussion, following the two technical sessions, will allow industry representatives and other stakeholders to highlight the importance of private sector engagement in advancing food safety capacity building and present and discuss case studies from a food industry perspective.
