UNIDO will present its strategy for technical cooperation on Sustainable Cities, focusing on projects in Malaysia. Specifically, the objectives and expected outcomes of two relevant projects, "Sustainable City Development in Malaysia" and "Energy efficient low carbon transport in Malaysia", will be highlighted.

1. Sustainable City Development in Malaysia  
The project will directly contribute to integrated sustainability planning by integrating climate risks in urban planning and management. This will be achieved through:
  - Integrated approach to urban planning and management that is guided by evidence-based, multi-dimensional, and broadly inclusive planning process that balance economic, social and environmental resource consideration;
  - Building awareness and institutional capacity, and promote investment in climate risks mitigation technologies through demonstration projects
  
2. Energy efficient low carbon transport in Malaysia  
The project will catalyze and accelerate widespread use of electric vehicles (EVs) as part of energy efficient low-carbon transport and low-carbon cities initiatives of Malaysia. This will be achieved through:
  - Improvement of policy and regulatory framework for EV use and local manufacturing; strengthened capacity of concerned institutions and awareness raising
  - Development and demonstration of infrastructure for EVs, and local EV manufacturing capacity

Brief description:

The United Nations Industrial Development Organization (UNIDO) promotes the mainstreaming of eco-industrial parks (EIP) in developing and emerging economies and is currently implementing a comprehensive programme of seven (7) EIP pilot projects. Such parks have significant potential as they foster economic and social growth whilst safeguarding the environment. Thus, eco-industrial development integrates business and environment to create economic opportunities and improved eco-systems as well as innovative avenues for business.

Past experiences in the area of EIP developments have proven the approach to being highly relevant when ensuring sustainable industrial development. As demonstrated internationally, EIPs enable companies to benefit from greater collaboration and exchanges, within companies (between management, technical and environmental staff, finance, etc.) and between companies, government and service providers. Companies are enabled collectively to turn environmental problems into business opportunities using resources efficiently and cooperating through shared resources. Hereby, UNIDO follows a holistic EIP methodology ranging from approaching companies on an individual level over industrial symbiosis concepts and the inclusion of infrastructural, management and zoning structures.

In this regard, the EIP pilot projects focus firstly on the creation of minimum criteria to move towards a consolidated national understanding of what constitutes an EIP. This framework can be applied to support the planning and development of new eco-industrial parks (Greenfield approach) as well as help to further develop and upgrade existing industrial parks into EIPs (Brownfield approach).

Secondly, in order to support the transformation of the selected pilot industrial zones into eco-industrial parks it is important to coordinate efforts and strengthen the overall capacity on eco-industrial park planning and management at the central park level.

Brief description:

The Global Environment Facility (GEF) launched the Sustainable Cities Integrated Approach Pilot (SC-IAP) to help cities address the challenges posed by mega-trends (urbanization, rising middle class and population growth) of global environmental degradation, in an integrated manner. UNIDO is one of the

specialized agencies assisting countries in accessing GEF SC-IAP set aside funds, primarily building on the country allocations the focal areas of climate change and chemicals and waste. UNIDO-GEF projects under this initiative include:

**Sustainable Cities Integrated Approach Pilot in India:**

To integrate sustainability strategies into urban planning and management to create a favorable environment for investment in infrastructure and service delivery, thus building the resilience of the five pilot cities, i.e. Mysore, Jaipur, Vijayawada, Guntur and Bhopal. The expected outcomes of the project include:

- Increased scope and depth of integrated urban sustainability management policies and processes, including institutionalization within the local governance structure;
- Low-emission and environmentally-sound technologies contribute to city greenhouse gas emission reduction;
- Promotion of "Sustainable Cities" through partnership approach.

**Sustainable-city Development in Malaysia:**

The proposed child project will directly contribute to the IAP goals of integrated sustainability planning, namely: integrating climate risks in urban planning and management. This will be achieved through:

- Integrated approach to urban planning and management that is guided by evidence-based, multi-dimensional, and broadly inclusive planning process that balance economic, social and environmental resource consideration;
- Building awareness and institutional capacity, and promote investment in climate risks mitigation technologies through demonstration projects.

**Sustainable cities initiative for Senegal:**

The proposed SC IAP project will support specific activities related to storm water management and climate change adaptation, while also promoting more integrated long-term strategies. Under the project UNIDO's interventions will focus on Diamniadio industrial park which is a 52 hectares site intended to host manufacturing factories and an administrative building.
