SUMMARY OF MEETINGS

TUESDAY, 22 November 2016

1st PLENARY MEETING (morning)

The forty-fourth session of the Industrial Development Board was opened by H.E. Mr. SONG Young-wan (Republic of Korea), outgoing Acting President of the forty-third session.
