Late 2021 marked an important turning point for UNIDO, as a new Director General was elected: Gerd Müller, former German Federal Minister of Economic Cooperation and Development. His election was confirmed during UNIDO 19th General Conference (GC). He will succeed Li Yong who has led the organization since 2013.

As the EU delegation recalled during UNIDO GC: "The issues we need to address require global solidarity and global solutions that can only be achieved through international cooperation and a strong multilateral approach. We consider the whole UN system, including UNIDO, to be key players in this regard." As a German and former Member of the European Parliament, our new DG is surely up to the challenge: intensifying our UNIDO-EU cooperation for concrete actions.

UNIDO General Conference confirmed Gerd Müller as new Director-General





VIENNA, 29 November - 3 December 2021 - The mandate of **Gerd Müller**, former German Federal Minister of Economic Cooperation and Development, as **the new Director-General of UNIDO** was confirmed during UNIDO's 19th General Conference. The event took place at a critical juncture following the Secretary-General's call for a "Decade of Action" and in light of the prolonged economic recovery in store for countries all over the world. It was a great opportunity to hear from UNIDO member states and visualise how UNIDO capitalises on its rich expertise to promote and implement inclusive and sustainable industrial development.

On this occastion, Mr. Antti Pekka KARHUNEN, Director for Sustainable Finance, Investment and Employment at DG INTPA, spoke at the Eigth Forum on Inclusive and Sustainable Industrial Development (ISID). He welcomed the Programme for Country Partnership (PCP) as an initiative the EU was proud to be part of, and stressed that "the EU is grateful to have a partner like UNIDO and looks forward to continued cooperation."

As UNIDO Coordinator for the OYA Program, Mouna Lyoubi was invited to speak on the panel "Right by youth's side: preventing and mitigating the socio-economic vulnerabilities of youth". She shared her view on youth entrepreneurship and employability in Africa and reaffirmed the importance of strengthening youth access to trainings and opportunities. UNIDO's contribution to the Paris Peace Forum 2021 opens doors for further engagement at the highest level in the next edition.

Participation of UNIDO in the Sahel Alliance workshop in Brussels



BRUSSELS, 23-24 November 2021 - UNIDO Brussels Office participated in the in-person 2 days workshop of the Sahel Alliance in Brussels, gathering the European Commission, EU development agencies, financial institutions, development banks, and most major stakeholders active in the G5 Sahel countries. As members of the thematic group "Private Sector", they were able to present UNIDO's projects in the region and contribute ideas on how to provide innovative responses to development challenges in the Sahel.

UNIDO has played an active role in the **private sector working group** of the Sahel Alliance since 2020. One outcome of our engagement to strengthen cooperation for a more effective support to the private sector, was the organization in June 2021 of a technical workshop on the cotton industry in Burkina Faso organised jointly with the EU Delegation in Burkina Faso.

UNIDO co-organized CONCORDi 2021



BRUSSELS, 25 November 2021 - This biennial European conference on **business R&D and innovation** addressed issues related to the economics and policy of business R&D and innovation. The event was organized by the Joint Research Centre of the European Commission in association with the European Association for Research and Technology Organizations (EARTO), the Organization for Economic Co-operation and Development (OECD) and UNIDO. It brought together high-level panelists involving substantive discussions, notably on the issues of post-covid economic recovery in developing countries. Patrick Gilabert, UNIDO Representative to the European Union, intervened at the closing plenary session for policy makers and highlighted the importance of skills intelligence and networks to make an impact in the least developed countries and emerging economies, for a people-centred, digital and green transition.

UNIDO at COP 26







GLASGOW, 32 October – 12 November 2021 - UNIDO sent a delegation to the COP 26 UN Climate Change Conference to deliver important messages about the role of industry in saving the planet and its people from global warming. In an interview with COP26TV, Rana Ghoneim, Chief of UNIDO's Energy systems and Infrastructure Division, highlighted the imperative of shifting to green materials and technologies in order to achieve the Paris Agreement goals and be part of the global response to the climate crisis. On 8 November, the Global Environment Facility (GEF) announced 10 new winners of its Challenge Programme for Adaptation Innovation, a competition that provides seed funding for innovative initiatives designed to help vulnerable countries cope with the worsening climate crisis. UNIDO will be the implementing agency for three of the 10 project selected.

Industrial Development report 2022




